
Dear Paul:

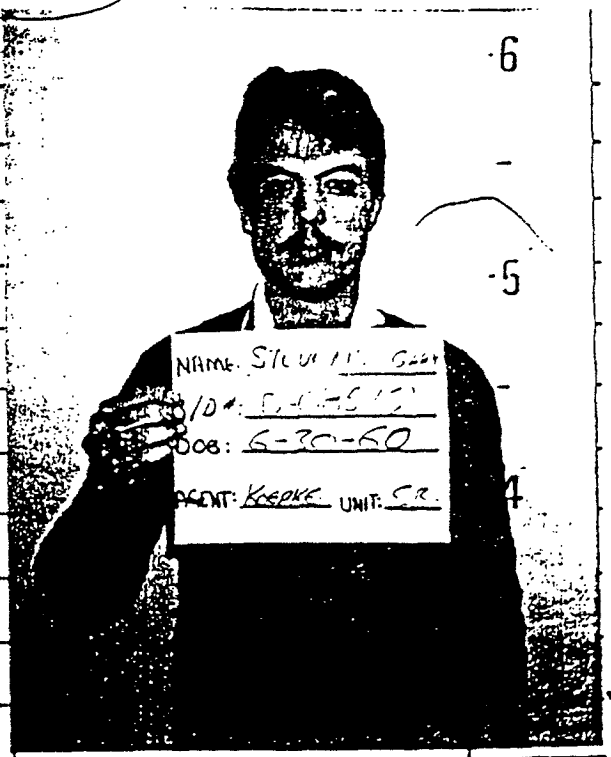
