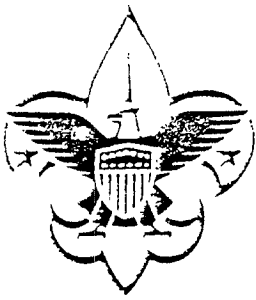

GALENA, Ill. — Former East Dubuque scoutmaster Gary Radloff will serve a four-year sentence for sexually abusing two teenage boys on a scout camping trip.

Circuit Judge John Rapp, Jr., sentenced Radloff Monday afternoon to four years each for two counts of aggravated criminal sexual abuse and one year each for two counts of criminal sexual abuse. Rapp ordered Radloff to serve the terms concurrently, thus the total sentence is four years.

Rapp set Radloff's appeal bond at \$75,000 and referred him to the Illinois Department of Corrections for imprisonment.

Rapp denied a motion for a new trial Monday by Radloff's attorney, William Kelly. Kelly argued that there was insufficient evidence for Radloff's conviction.

Radloff, 40, faced up to seven years in prison and a \$10,000 fine. A Jo Daviess County Circuit Court jury found Radloff guilty June 23 after a two-day trial.

Radloff performed oral sex on two East Dubuque boys, then 12 and 13, on a blanket during a Boy Scout camping trip in June 1986, Jo Daviess County State's Attorney Christopher Moore said during closing arguments.

The two boys testified against Radloff.

Radloff was scoutmaster of Boy Scout Troop 14 in East Dubuque for four years. He was suspended as scoutmaster in October when scouting officials became aware of the investigation.

Tri-state scene Radloff guilty of sexual abuse

GALENA, Ill. — Former East Dubuque Scoutmaster Gary Radloff was found guilty Thursday of sexually abusing two teenage boys on a 1986 camping trip.

A seven-man, five-woman jury deliberated three hours before returning its verdict in Jo Daviess County Circuit Court.

Radloff, 40, was convicted of two counts of aggravated criminal sexual abuse and two more of criminal sexual abuse. He could receive up to seven

years imprisonment and a \$10,000 fine at his July 27 sentencing.

Radloff performed oral sex on two East Dubuque boys, then 12 and 13, on a blanket during a Boy Scout camping trip in June 1986, Jo Daviess County State's Attorney Christopher Moore said during closing arguments Thursday.

The two boys testified against Radloff at the two-day trial. Moore said each boy saw Radloff performing the act on the other, "and you can't get more corroboration than that."

The boys played cards in the county superintendent's office while the jury deliberated down the hall in the courthouse Thursday afternoon.

Defense attorney William Kelly of Galena contended in his closing statement that the boys had continued to see Radloff and go on camping trips

with him after the incidents, and didn't bother reporting him until more than a year afterward.

"They didn't hate him enough to stop seeing him," Kelly said.

Moore countered, "Have you ever heard the phrase, 'paralyzed by fear?'"

As for the delay in reporting the incidents, Moore said a boy would be reluctant to discuss "homosexual experiences at a time when he doesn't know what the devil his sexual identity is."

Moore said the boys had difficulty "dealing with events that are intrinsically shameful."

Moore said Kelly tried to convince the jury that Radloff is "a regular guy, just like you and me."

Kelly had told the jury, "This is what the danger is — any of us could be ac-

cused," citing as an example parents who take their baby sitters home alone.

Radloff, a Dubuque native, is a former maintenance worker and bus driver for the Hillman House retirement home in East Dubuque. He was fired after being charged in November.

Radloff was scoutmaster of Boy Scout Troop 14 in East Dubuque for four years. He was released Oct. 24 after authorities informed scout leaders of the investigation.

The mother of one of the boys said the family filed charges because "we were so hurt that we had trusted him. We couldn't take a chance of him doing it to my younger son. He's 12. There are too many boys coming up to that age. And since no one else would come forward..."

His father said, "It had to be stopped."

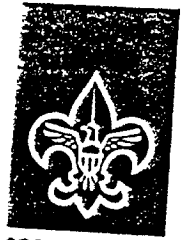
Tuesday, December 29th at 10:30 P.M. - - - Returned Lynn Milroy's (troop committee chairman) phone call. She informed me that [redacted] (Gary's [redacted]) called "demanding" that Lynn provide her (Mrs. Radloff) with the troop's advancement record book. I instructed Lynn to not turn over any of the troop's records to any member of the Radloff Family. I informed her that any request for scouting records needs to be made by Gary Radloff's attorney by way of contact through the Scout office.

Thursday, December 31 at approximately 10:00 A.M. - - - Gary Radloff called requesting that I arrange to provide him with Troop 14's Advancement record book. He said there was something in it which would help to determine his innocence. I informed Radloff that I needed to talk to our council attorney before anything was done.

Thursday, December 31 at approximately 4:30 P.M. - - - Mike Coupe, our council attorney returned my call. After learning of Radloff's request, Mike instructed me to not provide Radloff with any troop records. He said any request for troop records must be made through Radloff's attorney. If a request is made by his attorney, we would allow an examination of the records.

Radloff pleads innocent

GALENA, Ill. — A former East Dubuque, Ill., Boy Scout leader has pleaded innocent to four counts of sexual abuse in connection with the abuse of four youths during a 20-year period.

Gary Radloff, 39, of East Dubuque, Ill., pleaded innocent Monday afternoon to two counts of aggravated criminal sexual abuse and two counts of criminal sexual abuse at his arraignment before Circuit Judge Harold Negel.

Radloff, who was suspended from his post as scoutmaster of Boy Scout Troop 14 in East Dubuque in October,

is free on bond pending a Feb. 8 court appearance.

Jo Daviess County Sheriff's Department detective David Roling said Radloff sexually abused a 14-year-old boy and a 15-year-old boy on a camping trip in June 1986. Radloff sexually abused two other young men in the early 1970s, Roling added.

"What we have heard here today is that we have proof of a 20-year-old pattern of abusing young boys," State's Attorney Chris Moore said at Radloff's previous court appearance.

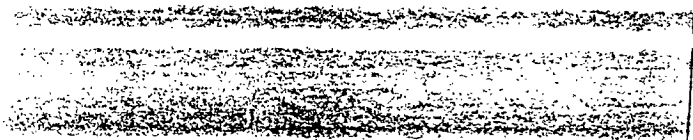

Tuesday, November 24 at approximately 9:00 P.M. ---

I talked with [redacted] about counseling for her [redacted]. She informed that [redacted] indicated he has been molested by Radloff but that he doesn't wish to discuss it with anyone close to him. [redacted] said she didn't discuss the possibility of counseling with [redacted] and mother. She said she would before final arrangements are made for counseling. I informed [redacted] that the Scouts would pay a maximum of \$100.00 per counseling session, one per week for three months. We agreed that I would make some contacts to find the best doctor for this type of situation. I informed [redacted] that all arrangements would remain confidential. [redacted] gave me her work number so that it would be easier for me to make contact with her.

Saturday, November 28 at approximately 11:30 A.M. ---

[redacted] called to inform me that the troop 14 is having difficulty getting the troop's equipment from Gary Radloff. Apparently Radloff has been instructed to not communicate with any members of the Scouts. According to [redacted] it appears as though he is using this as an excuse to not turn over the equipment. [redacted] feels Radloff may be keeping the channels of communication open with [redacted] and [redacted].

I suggested that Lynn attempt to get the equipment one more time by working through [REDACTED] or [REDACTED]. I told

her to call me on Monday if she doesn't have any success and that I would make arrangements through our legal counsel to get the equipment.

Monday, November 29 at approximately 9:30 AM ---

I communicated with Mike Lyle, Council Attorney regarding the problem the troop was having securing the equipment from Radloff. We unsuccessfully attempted to get Jeff Tranel (Radloff's former attorney) on the phone with us. Mike suggested that I continue trying to make contact with Tranel

Monday, November 30 at approximately 10:00 AM ---

Made contact with Tranel and found out that he no longer is Radloff's attorney. Jeff gave me the name and phone number of Lou Francomb, Radloff's new attorney.

Monday, November 30 at approximately 11:00 AM ---

Made contact with Lou Francomb and made him aware of the equipment problem. He said he would contact Radloff and make arrangements to transfer the equipment

Monday, November 30 at approximately 11:30 AM ---

Lou Francomb called to inform me that Radloff dropped all the troop equipment off in [redacted] yard this morning.

Monday, November 30 at approximately 1:30 PM ---
Received a call from [REDACTED] informing
me that he now had control of the troop
equipment.

Monday, November 30 at approximately 2:00 PM ---
Called [REDACTED] to let her know that
arrangements were made through Dr Douglas
McCullum to have counseling for her son [REDACTED].
I gave her Dr McCullum's phone number so
that she could schedule the first appointment.
The limitations regarding [REDACTED] support
for counseling provided by the [REDACTED] was reviewed
with her. At the special meeting we
held in E Dubuque for parents, Scouts and
committee members, [REDACTED] expressed some
support of Gary Radloff by reminding those
in attendance that he is innocent until proven
guilty of which everyone agreed. I wondered about her support
of Radloff so I asked her when [REDACTED] told her he
had been molested. She said she found out
after the meeting on the same evening.

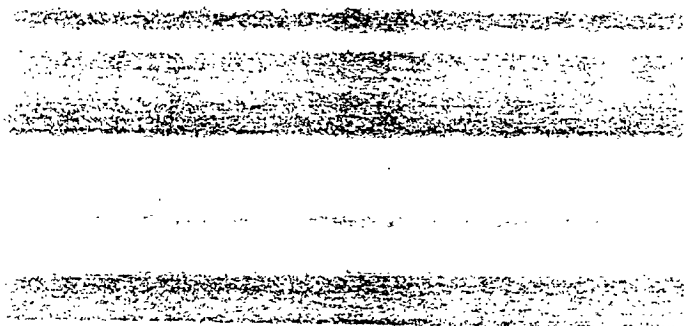

[redacted] and myself met with the Scouts, parents and committee of Troop 14.

A total of 17 Scouts and 12 adults were in attendance not including the 3 council personnel.

Attached is the agenda which was followed at the meeting. The attitude of those at the meeting was very positive with most of the discussion dealing with how we (all present) could help to make the troop stronger. Concern was expressed over whether all Troop Funds were accounted for. Lynn Milroy, Committee Chairman now has control of the Troop Funds and feels the books are accurate with all Funds accounted for. Boy Scout, [redacted] made an accusation that former Scoutmaster Steve Williams misappropriated Troop Funds. [redacted]

[redacted] is an Assistant Patrol leader. He was the Scout concern was expressed about earlier in this narrative. At the conclusion of the meeting many parents came forward to thank us for the support we offered.

Thursday, November 19th at 8:15 AM - - -

I found a note on my desk written by District Executive, Merlin Behrke. The note

indicated that [REDACTED], a parent of one of the Scouts called Wednesday evening at 9:50 P.M. indicating a desire to have counseling for her son. The note said she would call again tomorrow (Thursday)

Friday, November 20th at 11:35 A.M. ---
I looked through the E. Dubuque phone book to find the phone number of [REDACTED] since she did not call on Thursday as indicated in the note I received. I was able to make contact with [REDACTED] sister-in-law who informed me that [REDACTED] had an unlisted number. She wouldn't give me the number but said she would arrange for [REDACTED] to call me. I gave her my home phone number.

Friday, November 20th at 9:00 P.M. ---
[REDACTED] sister-in-law called and gave me [REDACTED] unlisted phone number

Saturday, November 21 --- Three times during the day I attempted to make contact with [REDACTED] but was not successful.

Sunday, November 22 --- Two times during the day I attempted to make contact with [REDACTED] but was not successful.

N. Kirch . . . Background Information:

1. NEIC was notified of an investigation being made of Gary Radloff by law enforcement authorities due to an accusation of sexual child abuse made against him.
- 2.. The council immediately suspended Radloff's Scouting membership and removed him as Scoutmaster. If Gary were to approach you, have nothing to do with him. Unless he is proved innocent, he will never be involved in Scouting again.
3. IMPORTANT . . . Radloff has not been convicted of a crime at this time. Evidence however, indicates that he may be convicted in the future. We personally have no first hand knowledge to indicate guilt.
4. Our number one concern is the safety and welfare of your children and our Scouts. That is why we immediately removed Gary from the troop. It is also the reason we are here . . . to help in any way we can.

A. Chidley . . . BSA Concern

- Sexual abuse of young people has been a concern of the B.S.A. and it continues to be so. A confidential file of adults associated with child abuse has been maintained at our National Office to guard against their involvement with Scouting.

Pending safeguards to be implemented ~~to~~ include:

1. Booklets published for adults and youth members providing instructions on how to identify and deal with a child abuser.
2. Special training on the subject for Scouting Professionals and adult volunteers.
3. Implementation of a two to a team rule (no adult alone with a Scout at any time).

4. Adult volunteer applications rewritten to include questions about applicants background that might help to spot a molester.

The number one objective of the B.S.A. is to make Scouting as uncomfortable as possible for the child molester.

Prosecution to file more charges

GALENA, Ill. — An East Dubuque man sexually abused at least four youths over a 20-year period, a prosecutor charged in Jo Daviess County Circuit Court Tuesday.

Gary Radloff, 39, sat quietly during the preliminary hearing but did testify briefly about where he has lived and the three jobs he held before his arrest last week.

Radloff is charged with one count of aggravated criminal sexual abuse. However, the prosecutor, State's Attorney Chris Moore, said more charges would be filed before Radloff's arraignment at 3 p.m. today.

Radloff was released from custody late Tuesday afternoon after posting 10 percent of the \$50,000 bond that Associate Circuit Court Judge Eric DeMar had refused to lower.

Radloff was being held in the Carroll County Jail in Mount Sterling, instead of the Jo Daviess County Jail, for "security reasons," Sheriff Steve Allendorf said this morning.

In court Tuesday, Moore questioned Jo Daviess Detective David Roling about the investigation that led to Radloff's arrest.

Roling said an East Dubuque man first contacted the East Dubuque Police Department when he found out Radloff was the only one to attend an organizational meeting for a Big Brothers-Big Sisters group. The man said he had been sexually abused by Radloff as a teenager and said his younger brother also claimed sexual abuse by Radloff in the early 1970s.

Roling said he discovered Radloff was scoutmaster of Troop 14 in East Dubuque and contacted the Northeast Iowa Boy Scouts Council for a list of the troop members.

Roling said he then began contacting parents and interviewed a 14-year-old East Dubuque boy.

The youth "said on several occasions he (Radloff) had made sexual advances to him," Roling said.

The 14-year-old said he and a 15-year-old had gone camping with Radloff in June 1986 and that Radloff took the boys' clothes off, masturbated them and performed oral sex on them, Roling said.

The detective said the 15-year-old later supported those charges.

"What we have heard here today is that we have proof of a 20-year-old pattern of abusing young boys," Moore told Judge DeMar.

DeMar turned down the defense's request that Radloff be released on his own recognizance, and ordered that Radloff not have contact with members of his former troop if he did post bond.

Roling had said Radloff apparently met with some of the Scouts in his troop after Radloff was suspended from his post last month.

Sexual abuse charges made against ED man

GALENA, Ill. — An East Dubuque man appeared in court Thursday for an initial appearance on a charge of aggravated criminal sexual abuse.

Gary Radloff, 39, said nothing as Circuit Court Judge Harold D. Nagel explained the charge against him.

If convicted, Radloff faces three to seven years in prison and a \$10,000 fine.

A preliminary hearing and a bond reduction hearing in the case have been set for Tuesday at 1:30 p.m.

Radloff is charged with committing an oral sex act on a youth between the ages of 13 and 15 sometime in June 1986. Court papers identify the youth involved by the youth's initials.

According to a bond-reduction motion filed by defense attorney Jeffery Tranel of Dubuque, Radloff has no prior criminal record and no history of mental illness.

In addition, Radloff was approached by Jo Daviess County deputies several months ago about the impending charge but did not flee, the motion says.

Radloff was scoutmaster of Troop 14 in East Dubuque for four years. He was suspended from that position Oct. 24 after authorities advised scout leaders of the investigation.

Jo Daviess County State's Attorney Chris Moore said any East Dubuque-area parents who are concerned their sons may have had some involvement with Radloff should call the county sheriff's department.

Scoutmaster charged with assault

GALENA, Ill. — An East Dubuque scoutmaster, who led more than a dozen Boy Scouts for four years, will appear in court today on a charge of aggravated criminal assault.

Gary Radloff, 39, was arrested Tuesday and faces six to 30 years in prison and a \$10,000 fine if convicted on the charge, which involves having sex with someone under 13.

Jo Daviess County Sheriff's officials have refused to release details on the charges.

Radloff, who is being held in the Jo Daviess County Jail on \$50,000 bond, is to appear in Circuit Court today for an initial hearing.

Radloff, who was a maintenance worker at the Esther Hillman House in East Dubuque, was suspended as a scoutmaster Oct. 24, according to Steve Rankin, executive director of the Northeast Iowa Council of the Boy Scouts of America.

"As soon as we were made aware of the investigation of Gary Radloff, we took immediate action," Rankin said. "We simply told him his position was suspended because of an investigation that might show he was not up to the scouting standards."

Rankin, who has headed the Northeast Iowa Scouts since last fall, said there does not appear to be any file on Radloff in his Dubuque office.

"There was nothing that I inherited here that would indicate there was any concern about Gary Radloff," he said.

GALENA, Ill. — An East Dubuque man was arrested Tuesday by Jo Davies County Sheriff's deputies on a warrant charging him with aggravated criminal sexual assault.

Sheriff's deputies said they arrested Gary L. Radloff, 39, on a charge stemming from an incident that oc-

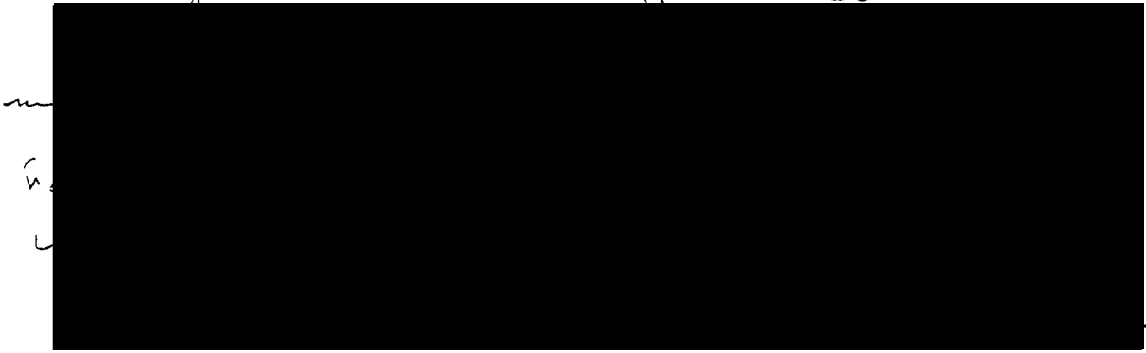
curred in rural East Dubuque. Deputies said the incident involved juveniles and refused to release any other details.



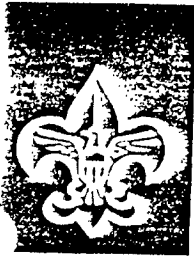

Friday, October 23 at approximately 7:00 P.M. --- Informed by District Executive, Merlin Behrke that Detective James Berning from the Jo Daviess County Sheriff Department was at the Scout Service Center at approximately 11:00 A.M. ^(Friday) requesting our cooperation with an investigation of Gary L. Radloff. Gary is Scoutmaster of troop 14 chartered to the Lions Club in East Dubuque, Illinois. Merlin informed me that, as a result of his meeting with Berning, he learned that a former Scout of Radloff has ~~accused~~ ^{accused} him (Radloff) of having homosexual activity with him (the former Scout). Merlin also informed me that previously, an anonymous phone call was made to the Jo Daviess Sheriff Department informing them that Radloff was attempting to be a Big Brother and that he should be denied membership because he is a homosexual.

At the conclusion of my conversation with Merlin, I immediately checked to see if Radloff was at the Camporee with his troop. He nor his troop were at the Camporee.

At approximately 7:30 P.M., Friday - October 23, I met with Council President, Norm Kirch to inform him of



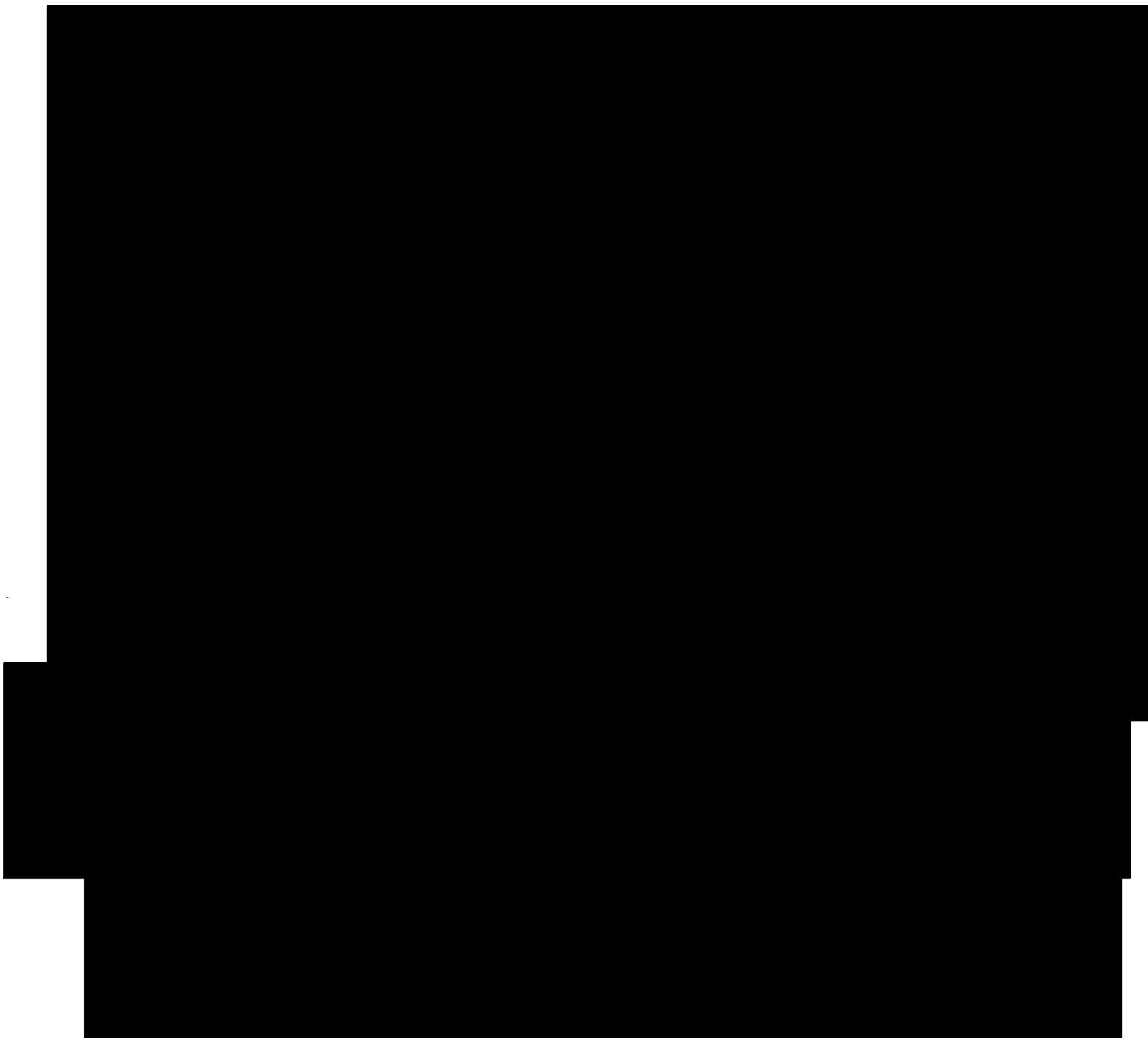

THE FACTS:

Gary Radloff, Scoutmaster, Troop 14, operated by the Lions Club of East Dubuque, was removed from his BSA position on Saturday October 24 following allegations of homosexual involvement with a 14-year-old ex-Scout. There are no police charges and no arrests.

According to Rankin the council was alerted to the allegations by a detective who came to the council camp during a camporee. Radloff was confronted with the allegations shortly thereafter when he arrived at the camporee with his troop. The matter came to police attention during an investigation of two apparently gay-related homicides (one of an adult, another of a youth) in the Dubuque area; although there is nothing at this time that related Radloff to the homicides. Police will give the 14-year-old a polygraph test.
