**Oroville Laborer Held
 In County Jail for
 Alleged Lewd Conduct**

OROVILLE (AP) — A 28-year-old Oroville laborer was being held in the county jail today for investigation of lewd and lascivious conduct involving several young Oroville boys.

Gary Lester Graves was arrested by deputies yesterday after an Oroville woman called the sheriff's office to complain that he had taken her young son into the country and that she was concerned.

Chief Investigator Richard Stenberg said this morning the case was being discussed with the District Attorney's office to determine how many charges will be lodged against Graves. Stenberg said the alleged offenses involved at least four lads from 12 to 14 years old.


Dear Howard:
