ORDER OF PROBATION FOR GENE R. Young

You have been convicted of Battery Class B misdemeanor  
on this 15 day of April, 1986, given a suspended sentence  
of 180 days + 1000<sup>00</sup> fine - 2 courts and placed on probation for a  
period of one year.

The following are your terms of probation:

1. You shall not violate any laws or ordinances.
2. You shall find or keep employment. You shall support your dependants and meet your family obligations.
3. You shall not own or have under your control a firearm or deadly weapon without written permission from your probation officer.
4. It is your responsibility to report to your probation officer at least once a month or as directed by such officer. You shall permit your probation officer to visit you at home or any place designated by your probation officer.
5. You shall remain within the State Of Indiana unless you are granted permission to leave by your probation officer or the Court. Any time that you are outside the jurisdiction of the Court for any reason, you will agree to give extradition to the State of Indiana and return voluntarily to the jurisdiction of this Court.
6. You shall permit the Probation Department to conduct any and all tests, at any time or place, to determine if you are in possession of illegal drugs. You are to answer truthfully all questions asked by your probation officer.
7. You shall notify the Probation Department promptly of change of address or employment. If you are detained, questioned or stopped for any reason by a police officer, you shall immediately notify your probation officer.
8. You shall not associate with any person who are in any sort of trouble with the law.
9. You shall pay the following: 50<sup>00</sup> each month  
Restitution to be determined by Probation for mental health victims cash  
full Initial Probation Fee of \$50.00.  
\$10.00 per month probation-users fee.

10. You shall follow all orders given to you by the Court or your probation officer.

11. Special terms No participation in Boy Scouts, Big Brothers, YMCA, 4-H or other youth organization during probation

b) Defendant will continue in mental health counseling until released by  
If the Court has reason to believe that you have violated any part of the terms of your Probation, it may issue a summons for your appearance or a warrant for your arrest. If the Court finds that you have violated any of the terms of your probation, it may continue you on the existing conditions, or it may order imposition of the sentence that was suspended and commit you to the Department of Corrections.

- r. 26, 1986 - Comes now Howard E. Petersen and qualifies as special judge by taking Oath, (H.I.).

Cause is set for trial on June 4, 1986, at 9:45 a.m. (Copies to C. Benson, R. Young, Special Judge Petersen and File.) S.J.

- r. 2, 1986 - On motion of Prosecuting Attorney, additional omnibus hearing is set for April 25, 1986, at 2:00 p.m. Change of Plea motion will be reviewed at that time. If trial is still needed, it is rescheduled for May 28, 1986, at 1:00 p.m. (Copies to C. Benson, R. Young, Sp. Judge Petersen & File.) S.J.

- Apr. 25, 1986 - Come now the defendant in person and by counsel, Randy W. Young, and the State of Indiana by David L. Henry, DPA.

Hearing held on defendant's Motion to Enter a Plea of Guilty (H.I.) and defendant's filing of Psychological Services Associates report (H.I.), which is read in evidence. The Court having heard the arguments of counsel, statements of defendant, finds there is a basis in fact for the defendant's offered plea of guilty to Battery, a Class B misdemeanor, as alleged in Count I and Count II in the Information. Further, that said plea is voluntarily and accurately made. The Court now accepts the plea agreement, for the reason that the victims and their mothers feel that the minor children will suffer damage if required to testify in this case, there is a family relationship, and it appears that the defendant was suffering from depression at the time, and that the acceptance of this plea agreement will save the taxpayers of Steuben County, Indiana, the cost of calling a jury, and the defendant has voluntarily entered treatment, and is capable of rehabilitation in the Court's mind.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the defendant be committed to the Department of Correction for a period of 180 days and fined in the amount of \$1000.00 in each case, that he is now placed on probation, and all of the jail sentence and \$950.00 of the fines are now suspended in each case, on the following terms and conditions: [INSERT ORDER OF PROBATION].
