Notes regarding George Hooper Sr.:

1/29/87

3:00 p.m. Recieved a call from Richard Loud, SM T348 in West Point, Ca. He shared his concern regarding a "rumor" to the effect that George Hooper (MC T348) had been arrested for a child molest. He indicated that another member of the committee had told him of the potential problem but had no definite information.

I advised Richard to wait until I had a chance to "Do some checking" before he did or said anything.

Immediatly following the conversation with Loud, I phoned the Calaveras County Sheriffs office for Fred Garrison, County Sheriff and member of our Board. He was not available, I left a request for him to call me.

1/30/87

9:00 a.m. I reached Fred Garrison by phone, shared the situation with him. He confirmed the fact that George Hooper had been arrested in West Point for sexually molesting an 8 yr. old girl. He advised that Hooper should not be involved in Scouting in any way.

9:20 a.m. Reached Richard Loud by phone. Shared the facts of Hoopers arrest and informed him that Hooper was not to be allowed any further involvement with the Troop and that we would take the apporprate steps to remove Hooper from our roles. He indicated that he would inform their chartered partner (the West Point Lions) and Danny Link, CM P348.

12:30 p.m. Spoke with Paul Ernst in the National Office. He advised that a letter be sent over our Council Presidents signature informing Mr. Hooper that util his case was resolved his registration in Scouting is suspended.
