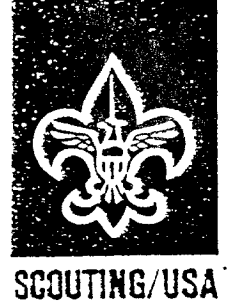


This is in response to your inquiry concerning information on the above individuals.

Sex charge filed

A Rockford man has been charged with a sex attack on a youngster.

Gerald R. Jarman, 44, 1126 Jackson St., was charged with aggravated criminal sexual abuse.

Detectives said the charge results from an incident involving an 8-year-old boy.

Jarman was arrested Tuesday and released after posting 10 percent of a \$3,500 bond.
