Scoutmaster guilty of sexual abuse

A Boy Scout leader on Tuesday pleaded guilty to five counts of aggravated criminal sexual abuse for having sexual contact with a 14-year-old Scout.

Glen Madigan, 31, of De Kalb, appeared before Judge Michael Pope in the Des Plaines branch of Cook County Circuit Court, where he was sentenced to 4 years of supervised probation and 180 days in Kane County Jail. Madigan will receive counseling as part of his probation, according to Assistant State's Atty. Thomas Riordan.

Madigan was arrested by Bartlett police on April 14, 1988, after the boy's mother reported she had learned Madigan had made advances toward her son, Riordan said.

Madigan's jail sentence will run concurrently with another 180-day jail sentence Madigan is serving in Kane County for a similar charge, Riordan said.

Ex-Scout leader charged with assault

A former northwest suburban Boy Scout leader was charged Thursday with sexually abusing a member of his troop, the second time this year a former Scout leader has been so accused.

Glen Madigan, 30, of 807 Ridge St., De Kalb, was arrested at his home Thursday and charged with four counts of aggravated criminal sexual abuse against a boy over a period beginning in the spring of 1986 and ending last September, said Lisa Howard, spokeswoman for Cook County State's Atty. Richard Daley.

The incidents allegedly took place when Madigan lived in Bartlett. He allegedly would invite the boy to his home after troop meetings, serve him liquor, show him pornographic magazines and then abuse him. The boy, now 16, was 14 and 15 years old at the time, Howard said.

In February and March, Thomas E. Hacker, 51, former leader of a Scout troop from Oak Lawn and Burbank, was charged with molesting 12 boys. The boys either were Scouts or knew him from the Burbank Park District, where he was director, according to authorities.

Madigan is suspected of other sexual offenses, Howard said. "We believe there may be incidents in

Wisconsin," at a Boy Scout overnight camp, "as well as in Kane County," she said. Officials from the Kane County state's attorney's office and authorities in Wisconsin are investigating, Howard said.

The investigation of Madigan, now a student at Northern Illinois University, began April 4 with an anonymous tip to the Illinois Department of Children and Family Services' child abuse hot line, Howard said. The inquiry was conducted with the cooperation of Boy Scouts of America.

Madigan joined the Scouts in the spring of 1986 and left in September of last year, when he entered Northern to get a teaching degree, she said.

His Scout troop consisted of boys from throughout the northwest suburbs and was a member of the organization's Two Rivers Council, she said. On his application to lead the troop, Madigan said he had previously led Scout troops in Oregon and Idaho, Howard said.

Madigan was in the custody of Bartlett police Thursday night on a \$20,000 arrest warrant bond, she said. He was scheduled to appear in Cook County Circuit Court in Hanover Park Friday morning.

The investigation was conducted by the Cook County state's attorney's Mass Molestation Task Force.

Abuse of Boy Scout alleged

Ex-Bartlett man faces sex charges in two counties


BARTLETT — Bond for a 30-year-old DeKalb man, formerly of Bartlett, was set at \$25,000 this morning after he was charged Thursday with five counts of aggravated criminal sexual abuse stemming from his involvement as a Boy Scout leader.

Glen Madigan of 877 Ridge St. was charged in Cook County with sexually abusing a male teenager in five separate 1986 incidents. Four occurred in Madigan's Bartlett home and the fifth in an undisclosed Bartlett location, according to statements made in court today.

The Kane County State's Attorney's Office today also authorized two counts of criminal sexual assault and two counts of aggravated criminal sexual abuse against Madigan. The incident involves a teenager under the age of 16 in November 1987, Kane officials said. They said the Kane County charges resulted from the original investigation in Cook County.

Bond in Kane County was set at \$100,000.

Cook County officials said it

was a "very serious situation" and the investigation is continuing.

"We feel there are other victims out there," said Lisa Howard, a spokeswoman for Cook County State's Attorney Richard Daley.

Madigan is a graduate student in secondary education at Northern Illinois University and is pursuing a teaching degree, according to court statements. He lived for one year at 561 Deer Park Circle in Bartlett, moving in March 1987, police said.

He was a troop leader for

Unit, DCFS, the Department of Criminal Investigation, state police, and Bartlett police conducted the two-week investigation. Scouting authorities said they have been cooperating with police, but refused further comment today.

Bartlett police said the charge of aggravated criminal sexual abuse is punishable by three to seven years in prison and/or probation and fines.

Bartlett Boy Scout Troop 26 in 1986. Basically, the child was taken to Madigan's home after a troop meeting. He was given liquor and shown dirty magazines and the sex abuse occurred," said Howard.

"The victim is now 16 years old. There is only one victim out of Cook (County) right now," she said.

Bartlett police said the initial investigation began with a call to the Illinois Department of Children and Family Services hotline number. The names of the victims were not released.

Kane indictments cite sex assaults on teens

GENEVA — A Kane County grand jury Tuesday returned a four-count indictment against a former Bartlett scoutmaster accused of committing sex crimes against teen-age boys.

Glen A. Madigan, 30, who listed addresses at 807 Ridge Drive, DeKalb, and 120 Madera Circle, Carpentersville, was indicted on two counts of criminal sexual assault and two counts of aggravated criminal sexual abuse.

According to the indictment, Madigan used force to have oral and anal sex with a Kane County male under the age of 16 in November 1987.

Cathy Cavins, assistant Kane County state's attorney, said earlier that the homosexual acts took place while Madigan was living in Elgin. Although the victim was not a Boy Scout, Cavins said the incident is "connected" to Madigan's work as a troop leader.

Madigan is scheduled to appear Tuesday morning in Geneva before 16th Circuit Court Judge John Nickels. Bail is set at \$100,000.

Madigan, who was a graduate

student at Northern Illinois University prior to his arrest, was indicted in April by a Cook County grand jury on five counts of aggravated criminal sexual abuse.

Cook County authorities say Madigan sexually abused a male teen-ager in five separate incidents in 1986 while he was troop leader for Bartlett Boy Scout Troop 26.

Four of the incidents occurred in Madigan's Bartlett home, where he lived during 1986 and 1987, officials said. The fifth incident occurred in an undisclosed Bartlett location, according to court records.

Madigan remains jailed in Cook County, where bond is set at \$25,000.

Authorities said the teen-agers were given alcohol during the times they were sexually abused.

Officials in both counties said investigations will continue and more charges could be filed.

The investigation of Madigan began with a phone call to the Illinois Department of Children and Family Service's hot line, Bartlett police said.
