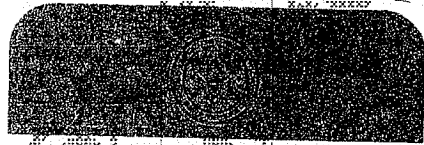

I am enclosing herewith, copies of statements taken by my investigator, Alan Peters, concerning the activities of Glenn Tobias.

I am enclosing a copy of a statement of [REDACTED], consisting of two pages, dated 6-17-69. I am enclosing a statement by [REDACTED], dated 6-17-69, consisting of one page and a copy of the statement of [REDACTED], dated 6-17-69, consisting of one page. Also a statement of [REDACTED] taken on 6-20-69, consisting of one page and a statement of [REDACTED], taken June 20, 1969, consisting of one page.

This is to advise you that I personally talked to Glenn Tobias's wife and she admitted to me that the charges of homosexuality leveled against Mr. Tobias was true.

In my position as Prosecuting Attorney, an agreement was worked out whereby there would be no prosecution against Glenn Tobias, so long as he secured medical help in dealing with his problem. Mr. Tobias presently is under the care of Russell C. Mathewson, M.D., Muncie, Indiana.

As Prosecuting Attorney, it is my personal opinion that Mr. Tobias should never be permitted to be placed in a position where he can have any dealings with boys.

If additional information is needed to secure this, please let me know.

*I told his wife on May 22nd another boy verified this fact on May 23rd, ~~that~~ I took both boys over to Tobias. They told Mrs Tobias what happened. I was not in the room when they told her so I don't know what they said. I would not let Mr Tobias be alone with the boys but insisted on staying in the room. When I faced ~~them~~ him with this he made the boys say in detail what he had done and he would not deny or admit it he merely said I don't know if*
