Thank you for your letter of June 26 concerning Gordon P. Miner, currently registered as Scoutmaster of Troop 398. We have placed this information in our files and have taken steps to have his name deleted from the Troop roster.

Enclosed is a confidential record sheet which we would very much appreciate your filling out and returning to us as soon as possible. As you know, in cases of this nature it is most important that we have as much supporting evidence as possible in our files in order to justify our position of refusing to accept any future application for registration from the individual in question. We, therefore, ask that you please send us all substantiating documents that may be available pertaining to this situation, such as a statement from the Sheriff's Department; copy of police record; any newspaper clippings, etc. This additional information will enable us to identify this individual should he ever again attempt to register in the Scouting program. Thanks for your help.

Since this leaves Troop 398 without any registered unit leader, undoubtedly, someone is taking over in this position. In order for the unit to continue to receive program inserts in Scouting Magazine, it will be necessary to advise this office of the name of the new unit leader. This should be done by filing with us an additional enrollment for this individual in his new position. Please do not file a separation notice as we have already dropped the current leader.

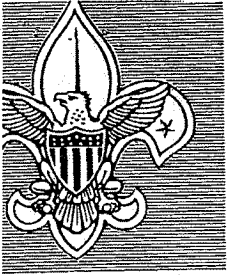

Today, June 26, 1968 I had a call from the Sheriffs Department of the County of Jackson. Mr. Miner was found in a drunken condition, with his automobile parked on a railroad track the night of June 24th. In checking their files they found an admitted sexual offense involving teenage boys in 1964.

Mr. Miner is 26 years of age, single, weighs approximately 200 lbs, and is about 5' 8" tall with a pimpled complexion.
