



Sex abuser gets probation

A former Boy Scout counselor was placed on three years probation yesterday for sexually abusing a 13-year-old scout who visited his home to get help in earning a photography meritically.

As conditions of probation, Nassau

County Court Judge Alfred Samenga
ordered 44-year-old Gordon Pugli to
undergo psychiatric treatment and
avoid any association with "young persons."

Pugh, an engineer for the New York Telephone. Co., was indicted in June 1975 on charges of second degree sodomy, attempted sodomy, sexual abuse and endangering the welfare of a minor.

The sodomy charges were dropped May 17, after Pugh interrupted his trial and agreed to plead guilty to the two lesser counts.

The indictment alleged Pugh sexually assaulted the boy on two separate occasions in August 1974 when he visited Pugh's home at 89 Trumbull Road, Manhasset.

Guilty Plea in Sex Case

Mineola—A former Boy Scout Connsclor pleaded gullty, yesterday to committing sevual abuse on a 13-year-old Scout he was beloing on a photography merit badge project.

The advisor, Gordan Pugh, 43, of 59 Trumbull Rd., Manhasset, entered the plea to reduced charges of second-degree sexual abuse and endangering the welface of a minor. Last June, Pugh was indicted on so-lony charges stemming from two separate August. 1974, incidents, in which the boy visited his home. Yesterday, County Court Judge Alfred Samenga ordered Pugh, who was freed without bail following his arrest, to return to court on July 9 for sentencing. He faces a maximum of two years in juil.

Boy Scout Aide Faces Charges of Sex Abuse

Mineole--A Almbaret Box from consider was imiteted by a Nascan Cannty grand jury yesterday on charges of second-degree sodony, attempted sedemy, segual abuse and endangering the welface of a El-year old segui.

Assistant Plansau District Alterney Jeseph Laurie said that the counceler, Gordon Pugh, 43, of 89 Trumball Rd., elicatedly compatted the nets when the boy went to his home twice last August to work on a photography merit budge. Pugh, who was a merit badge counselor, had volunteered to teach scouts photography in his spare time. He was not affiliated with a specific troop.

According to Exercise, the box's methor did not learn of the incident until April, when she filed a complaint against fregis.

Pugit was arranged in Narran County Court before Judge Raymond L. Willies and relevand in the curredy of his attorney, C. Maleutin Dawsey.
