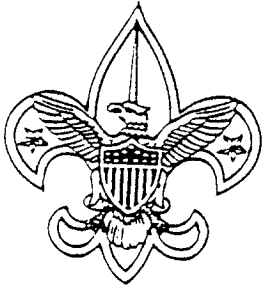

GORDON READE: Involved with BSA 152 out not registered with BSA

8/29/88 Megan Sacco, Exploring Executive was approached by Wayne Robson, Executive Director of Big Brothers / Big Sisters and told her of an incident where Gordon Reade had a homo-sexual relationship with [REDACTED] while Gordon was [REDACTED] "Big Brother".

I contacted Wayne Robson after Megan reported the incident to me and he reported the following to me. Details were also filled in by Susie Mortorall, a counselor involved with this case. They reported that the relationship happened approximately 1 1/2 years ago and was reported to their agency 1 year ago by the youth's father. No suit was ever made against the organization. The violation was reported to Child Protective Services in Santa Clara County and reported to the Mountain View Police Department. I could not find out if Gordon Reade was ever prosecuted.

Gerdy Reade has since reappplied to become a "Big Brother" for another youth. His application has been denied.

8/30 Contacted Richard Parker and informed him of the incident. He requested time to get more detailed information.


9/1 - Recontacted [REDACTED] & Susie
9/4 Mortorall by phone. They were unavailable and finally spoke with them on 9/14. They had no other information on the incident that they would reveal but did go over the same information once again.

9/20 Contacted Santa Clara Child Protective Services and was told that they could not talk about the case.

9/23 Contacted Steve Perry, Area Director and reported details of case.

9/27 Spoke with John Smith, Chief of Police of Mountain View. Said he could not talk about the case as mandated by law.

9/27 Spoke with Steve Perry who informed me to file Confidential Record Sheet with Paul Grant and have unit leader inform Jordan Peade that he could not be involved in the BSA programs. The Chartered Organization was informed through Capt. Klein to the Palms Flying Club and the spot advisor was told to inform Peade.
