BSA STATEMENT

For seventy-five years the Boys Scouts of America has had as its highest priority the health and safety of all who participate in the Scouting Program, and this continues to be the case.

A few days ago the York Adams Area Council BSA became aware of a situation which might be considered child abuse. Immediately upon learning of the situation the person allegedly involved was removed from his position and a full and detailed report was promptly made to York County Children and Youth Services, the agency designated by State law to receive and handle such reports.

The Council is fully assisting and cooperating with Children's Services in their investigation of the matter and will continue to do so.

We have been advised that the Confidentiality of Records section of Child Protective Laws specifically prohibit the public release of any further information on the subject.

Upon arrival at the apt of Greg Tracy, ^{not 4:40 PM} we found he was not in. While we waited he drove up. We were invited in to the apartment.

Greg asked if we would like a soda. Both George and I had a Pepsi.

Since Greg had called me on 5/6/85 in the evening requesting information on what was taking place with the Post, O.A. etc plus rumors about him, I let him open the conversation.

* Greg discussed the O.A. News Letter & it not being Brevit.

The first thing Greg said was I want to discuss what's going on?

Since I was the one who made the appointment, I did the talking.

I first answered his question by saying that yes there was a huge big problem. I also noted that as a friend and former leader him since he was a Scout, I would recommend he resign from all scouting positions and activities!

He responded that this was a real hard job and like the one with Ron Baker. I responded to that by saying that I worked for a week to help clear it up and it came out clean.

He responded by saying what I should do is resign, then the Post will pick up in the also printed out that there could be a case of slander. I noted that I had seen Jim his frame when [redacted] was drinking beer. He challenged me on this but finally admitted maybe [redacted] did take a drink. I noted that [redacted] was underage and that drinking leads to problems.

I again suggested he resign and he refused to answer yes or no. He did respond that he had been screwed around enough and he had enough.

I again suggested he resign and to let it drop. He jumped up and went to his desk. He returned with paper and proceeded to write very intently. He handed me a copy and said I hope your satisfied.

I tried unsuccessfully to get him to accept my friendship but he called me down.

When I approached him he said a few nasty remarks and walked away.

I then departed along with Henry and Jeff.


This letter acknowledges your recent report concerning [REDACTED]. Please be assured that York County Children and Youth Services is looking into the matter and complying with its investigative responsibilities under the law. If you have any additional information, or if new information comes to your attention which you believe would be helpful to the investigation it is important that you bring it to the attention of Dale Jorden, the assigned investigator. The agency's telephone switchboard is open from 8:00 a.m. to 4:00 p.m. on business days. After hours, or on non-business days an answering service will come on the line with whom you may leave a message. An after-hours caseworker is available for emergency intervention.

At such time as the investigation is completed, the agency will make every effort to send you a report on the ultimate disposition in this case. You should understand that some investigations, by their very nature, take a considerable period of time and therefore your patience is requested. Please call if you have any questions.

The Child Protective Services Law grants immunity to any person or institution participating in good faith in the making of a report or testifying in any proceeding arising out of an instance of suspected child abuse. The identity of any person who makes a report of suspected child abuse or a person who cooperates in a subsequent investigation is kept confidential, except when you allow disclosure.

Tom:

I am writing this immediately following our telephone conversation this evening.

I hope that The Boss finds that we don't have to bring the parents in on all of this incident business with [REDACTED] [REDACTED] does not want to bring his parents into the picture unless absolutely necessary, for he feels that it would cause them, and others in his family, an awful lot of grief. He does not want a story to get out, in the press or by word of mouth, that he was involved in any homosexual activity, whether he was innocent or not. Stories have a way of getting around and being changed and enlarged...you know what I'm talking about. That's why I went right to the source before I came to you about any of it, though, like you, I had had suspicions about Trek for at least a couple of years.

I did not begin to worry that something might actually be going on until [REDACTED] told me, at the Fall Ordeal last year, that Trek had gone down to Lutherville to bring him to camp for the weekend. I thought to myself, "He has something on his mind other than Scouting." There was a series of articles in the Centre Daily Times, our local daily here, about pedophiles. One of the articles said that men to watch out for are those who are constantly hanging around boys for no apparent reason such as athletics or Scouting, and who possess things which are not generally of interest to adults or a lot of things that might be of interest to boys. (BEER, COMPUTER, PORN FLICKS, CIVIL WAR STUFF--see a pattern???) After I read this series of articles, two names crept into my thoughts: Greg Tracy and Mike Hawn. Both were known to me to be frequently inviting Scouts to spend the weekend with them, "We can watch some movies. I have a VCR." Throughout the summer, Mike Hawn was always trying to do things to get younger staff members and CITs to like him. For example, he organized a staff trip to Hershey Park. Sounds innocent, but in view of incidents last summer, I tend to draw a connection in my mind.

As for Trek, last summer, when he was beginning to organize Post 1863, he was continually taking his followers off to some cabin or somewhere. Frequently, some of the staff who were in the cabin that Bill Grandia and I were to ride herd upon, spent the night with Trek in AP-3. This caused them to "like" Trek, as he would take them off to pursue recreational activities, whereas Bill or I would have to play the "heavy" and get after them when they did not spend the night in their assigned quarters. The individuals in question, off the top of my head, are [REDACTED], and the [REDACTED] brothers, though there were others, I think.

In a lengthy letter to Bob Nulph in September, my first

to him after summer camp '84, I remarked to him that I had read the series of articles on pedophilia, and that I was a little suspicious of Trek's dealings with [REDACTED]. One of the lines of my letter was "I hope something ugly doesn't happen." Well, unfortunately my fears were well-founded.

In camp on Saturday, after I finished interviewing [REDACTED], I had a few moments alone with [REDACTED] in the back office. I walked over to him, and said, softly, "Anything strange happen at Trek's house lately," and he looked at me with the oddest expression, and said "Strange?" as if he knew exactly what I was talking about, but didn't want to say anything. Then someone else entered, and so our conversation ended abruptly.

At any rate, [REDACTED] told me that when anything goes on at Trek's place of residence, he says something to the effect of "None of this is to go beyond this room." He drills that philosophy into the boys, and also causes them to think that if they do tell someone something, that they will be in a lot of trouble, or that it will cause them more grief than it would cause him. This particular kind of brain-washing is another trademark of a pedophile, or so I've read. I fear that [REDACTED] may be so brain-washed.

I found it extraordinarily interesting to hear that Michael Hawn was present when some of these incidents were taking place, and to my surprise, that Keith Collier was also there at one time or another. Now, one other thing bothers me. I don't have any good reason to suspect anything (or even a shaky reason for that matter), but Keith Collier's best friend is Bill Grandia. Anyway, I find it difficult to see either of the two involved with Trek and his, shall we say, "illicit" activities. Keith may have an extensive library of X-rated videos, but from talking with him about other matters, I am of the opinion that when it comes to Scouting, he is concerned with exerting only a positive influence on boys. And then there's Mike Hawn...

I am under the impression that [REDACTED] and [REDACTED] may be directing some other of Trek's victims to either you or I to give us some information, so don't be surprised if you start getting some phone calls. What is the proper way for you and I to proceed with such people? Should I direct any informants to you or do you think I should continue, if necessary, in the way I handled the [REDACTED] interviews? Perhaps The Boss has some information that he obtained at his training in such affairs, maybe some counseling pointers above and beyond what I've already been exposed to, or some other considerations that I should bear in mind, that could be photocopied for me to read.

I want to be very careful about all of this, for public relations reasons (i.e., leaks, especially), and also for the simple reason that we don't want to have a summer camp program director with a reputation for carrying out a personal vendetta against child abuse in Scouting. (Boy, is my imagination ever ripe these days!)

Well, I'll keep you posted on any developments which occur in this matter, and I'd like you to keep me posted as well, as I think that these boys are going to be keeping in touch with me as they contact other victims.

Also, Dave Bear will be contacting me soon with Bob Nulph's new address and phone number, so that I can get in touch with him and with his younger brother, who may be a commissioner prospect. By the way, if the younger Nulph asks me about salary, which he undoubtedly will, what should I say? Bob has probably already told him what commissioners at Tuckahoe were paid in 1983 and 1984.

I was relatively pleased with our turnout at Saturday's meeting, but I'll tell you, I'm really beginning to do a slow burn over Andy Denenberg. There will probably be another staff meeting Saturday, May 18, which will be the last one before camp, at least of the full (or nearly full) staff. I'm planning to write Andy a letter in the next 10 days or so, telling him of this next meeting so that he can plan way ahead to be there. It seems as though in some areas, we're ahead of the game regarding planning and staff readiness, while in others we're so far behind that we're going to have a lot of catching up to do come staff week.

Well, this is it. Good luck with your search for staff in the York area, and keep in touch.

Bob Nulph called me last night. Contrary to what Bear told us on Saturday, Bob's younger brother will not be applying for camp staff--he has decided to take a summer job in the Grove City area because of the distances and inconveniences involved with working with us. I will be meeting with Bob sometime next week to discuss the CIT program with him, so if there's anything you'd like me to bring to his attention...

P.P.S. Later, same day:

Dave Bear called me around noon, to say, among other things, that his archery prospect is much more interested in being a commissioner than being the archery director. It seems that Dave knew that this fellow was very much into archery, and thus assumed that he'd be interested in being archery director. When Dave asked him about being a commissioner, his enthusiasm for being on our camp staff increased tremendously. The young man goes to school in Rochester, and is from Keystone Area Council.

Also, since I "stole" two of Dave's staff from him on Saturday, I felt compelled to tell him what is going on with respect to the Tracy incidents. He said "Shit" several times during our conversation. Trek has asked him to help out in some way during a Post 1863 event scheduled for this weekend in Gettysburg, and he may be calling you or may have called you or The Boss concerning his further involvement with the explorer post.

I got your package today, and I've had a chance to look over the info briefly and very cursorily. Thanks a lot for sending it; I think it will be a big help.

TO: WHOM IT MAY CONCERN

DATE: April 10, 1985

On April 6, 1985, there was a meeting of some of the 1985 Camp Tuckahoe summer camp program staff at Camp Tuckahoe. Because of a letter of [REDACTED], age 17, dated March 22, 1985, the 1985 assistant nature/conservation director, I had suspected that some activities were occurring which were not in keeping with the aims, purposes, and ideals of Scouting, involving Gregory "Trek" Tracy.

During the staff meeting on April 6, I called aside [REDACTED], who, in a telephone conversation the night before, said that he would be giving me some information on the alleged illicit activities at the staff meeting the next day. [REDACTED] told me that Tracy invites youth over to his house to spend the night, under the pretenses of performing either Order of the Arrow or Post 1863 "work." Though such work does indeed occur there, Tracy also shows pornographic films and serves beer to the youth. Once when [REDACTED] was in a room alone with Tracy, he said that Tracy exposed himself to him ([REDACTED]), and that he then used very persuasive language to attempt to get him ([REDACTED]) to fellate him. [REDACTED] also remarked that Tracy "does perverted things with" people at his house. [REDACTED] said that other people were present, but not in the same room, when Tracy exposed himself to him, such as [REDACTED] and other Post 1863 members which he did not name. [REDACTED] also said that Tracy attempted to remove [REDACTED] clothing.

After I interviewed with [REDACTED] on this subject, I called aside [REDACTED], whom [REDACTED] said would also like to talk to me about Tracy.

[REDACTED] also reported that Tracy showed pornographic films and served beer to youth, including himself. He said that one night, after a Swimming Merit Badge session at the YMCA in York, Tracy took he and another unidentified young man back to his house. The three were watching a pornographic film and drinking beer, and after awhile Tracy and the other boy left [REDACTED] alone and went to another part of the house for approximately one hour. Later, [REDACTED] found the other boy apparently asleep on a bed in another room, totally nude. [REDACTED] was planning to sleep over at Tracy's house that night, and shortly after Holland discovered the nude boy, Tracy asked him to remove his clothing with no explanation several times. [REDACTED] refused to do so, and asked Tracy "Why?" more than once. [REDACTED] reported that Tracy has exposed himself once to him, and, as with [REDACTED], has used persuasive language to try to get [REDACTED] to fellate him. In addition, [REDACTED] reported that Tracy has massaged parts of his body, presumably in order "To get you

in the mood" to engage in sex with him. Also, Tracy has allegedly attempted to remove [REDACTED] clothing. [REDACTED] reported that Tracy has tried to position [REDACTED] hand so that he could manually stimulate his penis.

[REDACTED] speculated that Tracy's method in enticing boys into having sex with him, is that he gets them drunk on beer, shows them pornographic films, and then as they become further inebriated and perhaps sexually excited from viewing the pornographic films, he touches them and tries to undress them, and then proceeds to do other things if he is successful.

[REDACTED] also said that Tracy says things to the effect of "None of this is to go beyond this room" and implies that if you tell anyone else about anything that happens, that you will be in much deeper trouble than he (Tracy) will ever be. Such brainwashing techniques are commonly used by pedophiles and other child-abusers, or so I've read in articles in newspapers and magazines.

[REDACTED] reported that [REDACTED], and other unidentified persons, both youth and young adults were present when these events have taken place.


This letter is to let you know the results of our investigation of the allegations against Mr. Greg Tracey.



Immediately upon learning of the situation the person allegedly involved was removed from his position and a full and detailed report was promptly made to York County Children and Youth Services, the agency designated by State law to receive and handle such reports.

The Council is fully assisting and cooperating with Children's Services in their investigation of the matter and will continue to do so.

We have been advised that the Confidentiality of Records section of Child Protective Laws specifically prohibit the public release of any further information on the subject.
