DSS Worker Is Charged In Sexual Abuse Case

CORUNNA — A 34-year-old employee with the Department of Social Services in Flint has been arraigned in Shiawassee County circuit court on one count of third-degree criminal sexual conduct.

Guy P. Blondin of 217 N. Walnut, Vernon, entered a plea of not guilty Monday to a charge that he sexually abused a 14-year-old boy last February. An Aug. 18 pre-trial date is set for the defendant in circuit court at 10 a.m.

Blondin is employed by the DSS in the Aid to Dependent Children division, according to a worker at the DSS in Flint.

Blondin reportedly has posted a \$10,000 (10 percent) bond and is free from jail.

Third-degree criminal sexual conduct carries a maximum penalty of 15 years in prison upon conviction.
