## Scout council sued in sex attack

THE MOTHER OF A 13-year-old boy who was sexually assaulted by his scoutmaster in 1979 filed a \$2-million damage suit Tuesday against the Chicago Area Council of the Boy Scouts of America. The former scoutmaster, Gwenn Hale, 30, of 1159 N. Cleveland Ave., pleaded guilty to the charge last year and was sentenced to 16 years in prison by Criminal Court Judge Robert Sklodowski. Tuesday's lawsuit, filed by attorney Alan Barinholtz, says that Hale became scoutmaster of Troop 141 in 1979. In the summer of that year, according to the suit, Hale enticed the victim to his apartment on the ruse of letting him try on a scout uniform. Once there, Hale displayed a gun and assaulted the boy, the suit says. Hale, a former bus driver, was arrested one year after the incident when the boy eventually told his parents about the incident.

Merritt Daane, Area Director, advises that Mr. Hale was, in fact, the registered Scoutmaster at the time of the offense.

The offense did happen.

The Scout Troop, #141, is chartered by the Chicago Housing Authority.

The individual is now serving sixteen years in prison for the offense.

The council attorney advises the Chicago Council to do nothing at this time; however, they understand litigation is pending against the B.S.A. and Lowell Mark, Director of Field Service.

There is an opinion that I.N.A. is also doing nothing, pending action by the plaintiff, since they (I.N.A.) feel there is no case.

Evidently the same information also appeared on Channel 7 local news last evening, March 22, 1983.

A Boy Scout troop leader was sentenced to 18 years in prison after he pleaded guilty to sexually assaulting an 11-year-old Boy Scout. Gwenn Hale, 30, of 1159 N. Cleveland, entered the guilty plea before Criminal Court Judge Robert L. Sklodowski. Hale, who worked as a bus driver and was head of Boy Scout Troop 141, was arrested one year after the incident when the boy finally told his parents of the assault. According to assistant state's attorneys Paul Tsukuno and Joan Becker, Hale lured the youngster to his apartment and convinced him to undress by showing him a new Boy Scout uniform.

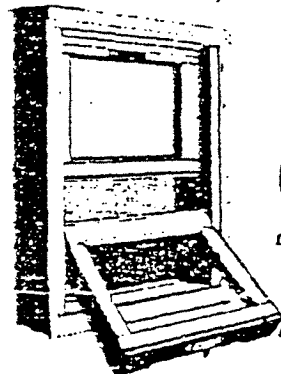
A Board of Education committee voted to serve a five-day eviction notice on the founder and president of an inner-city cultural program for falling \$18,000 behind in rental payments. Ben Branch, who received \$75,000 from Mayor Byrne this summer to promote GospelFest, has been renting School Board space at 225 S. Aberdeen for America's Music & Entertainment Hall of Fame. The board's real estate committee acted after Branch failed to make any payments, despite written assurances in August from state Sen. James C. Taylor (D-Chicago), a Byrne aide, that the rent would be paid. Branch, who founded the organization three years ago to assist disadvantaged inner-city young people in developing career and economic activities in the arts, also is the target of state Labor Department proceedings.
