On October 27, 1988 at 2:00 P.M. a reporter for the Herald-Mail newspapers in Hagerstown tipped me that one of our volunteers was under investigation for child abuse.

A call that afternoon to the Hagerstown City Police confirmed this allegation. Juvenile Investigation Officer William Rourke told me that he was investigating a former volunteer with a computer explorer post and that the individual had admitted to being a pedophile and using the explorer post to come into contact with kids.

My secretary remembered a call from Officer Rourke inquiring about Harold J. Murray and his involvement with the computer post chartered to I.B.M. Rourke had indicated that someone in my office might know who he was investigating because of an inquiry he had made earlier.
