EDGEWATER — A local businessman and former Edgewater Cub scoutmaster was arrested Thursday and confessed to having sexual activities with a teenage girl, Edgewater Detective Diana Floyd said Thursday.

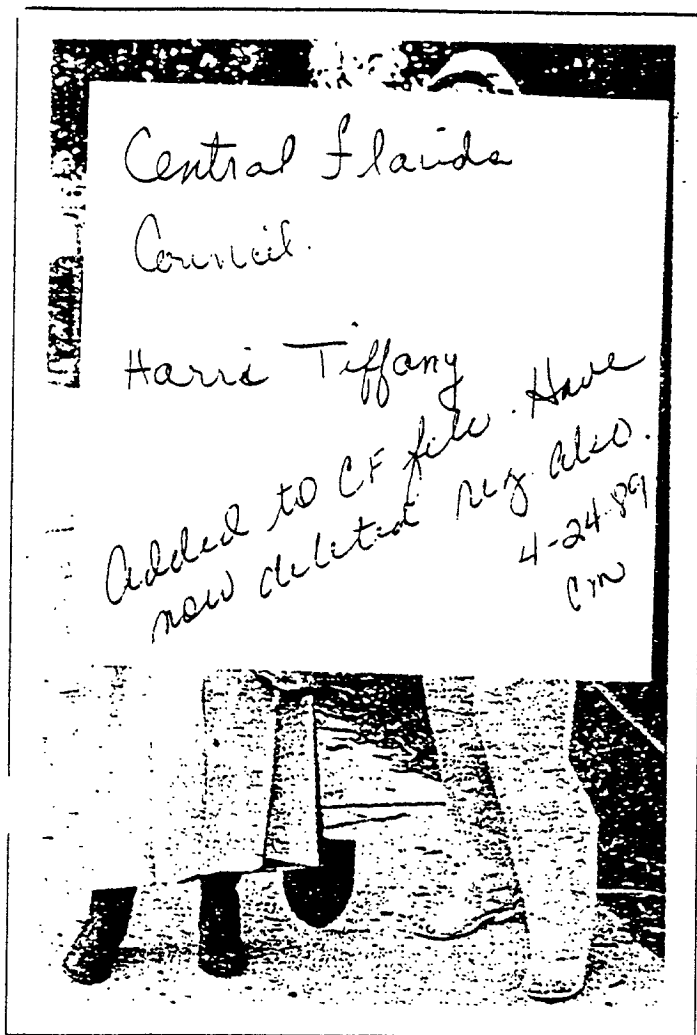
Mrs. Floyd said Harrison V. Tiffany, 45, owner of Tiffany's Auto Repair, 1428 S. Riverside Drive, confessed to Detective Leo Booth that he had oral sex and fondled the girl during the past two years.

Tiffany, arrested by Booth on a State Attorney's warrant, was charged with sexual battery, a felony, and was booked into Volu-

sua County Jail under \$10,000 bond, Mrs. Floyd said.

Mrs. Floyd said Tiffany was Edgewater's Cub scoutmaster for 10 years. She said he resigned from the post earlier this month.

“The investigation never has linked him to doing anything with the Boy Scouts,” Mrs. Floyd. “As far as we know, this is an isolated incident.”

Tiffany's wife, Pat, runs a babysitting service for about five families. Mrs. Floyd said “the investigation is no way linked to the babysitting service, either. I'd take my kids to Mrs. Tiffany.”

In a 1981 letter to the city, David Vakeil, Montsesano's attorney, said specific incidents giving rise to claim included the misrepresentation to Montsesano that they were required to hook up to the city's water, sewage and drainage system when they were not, representations that they needed to obtain a license to conduct their automobile painting operations and that the purchase of a "paint booth" would be a prerequisite for obtaining such a license.

## Man charged with sexual battery

A Edgewater man was arrested late last week on charges of custodial sexual battery.

Detective Dianna Floyd of the Edgewater Police Department said Tuesday that Harri Tiffany, 45, of 1952 Guava Drive, turned himself in to police Thursday night.

She said she had talked to the victim and the parent at that time. Floyd said she also questioned Tiffany, but he denied the allegations.

Thursday, however, Floyd said Tiffany confessed to the sexual bat-

arrest had previously been issued by the state attorney's office.

According to Floyd, a complaint against Tiffany was made April 1 by a 16-year-old female.

A spokesman at the jail said Tiffany was released on bond Monday. Although Tiffany was a former Boy Scout leader, Floyd said he resigned the position prior to the investigation.

"The arrest in no way affects the Boy Scouts," she said.
