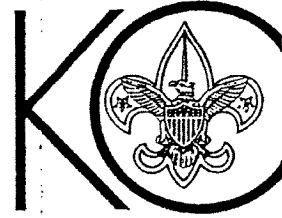



REMARKS: At 12:15 p.m. on 7-12-71 reporting officer received a call to report to the Detective Bureau at General Headquarters. Upon arrival contacted MR. [REDACTED] and his son [REDACTED] address given above. Reporting officer interviewed [REDACTED] in regard to a molestation that occurred on June 30, 1970. [REDACTED] stated that at approximately 9:00 a.m. on 6-30-71 his Scoutmaster, HARRY A. PALMER, picked him up at his sister's home. At that time they drove to Lake Jacomo to shoot bow and arrows. There were several other scouts present at the time. After shooting the arrows PALMER asked [REDACTED] if he

and then they sat down on a log. [REDACTED] further stated that PALMER asked him if he wanted to do some more shooting. He advised that he did. The suspect grabbed [REDACTED] testicles and said "Does it feel good?" [REDACTED] stated "no". They then returned to the other scout's location.

Palmer took the other scouts to their houses and returned [REDACTED] to his sister's residence. They stayed at that location for a short period of time and then left for the Independence Missouri Police range at Courtney Road and Kentucky Road. They arrived at that location at approximately 2:00 p.m. same date.

[REDACTED] and the suspect shot several bottle rockets and then fired the suspect's gun several times. They walked over to a log where the suspect put his arm around [REDACTED]. At that time he put his other hand down into his pants and touched his penis. [REDACTED] stated that he pulled away from the suspect and told him that he wanted to go home. The suspect returned [REDACTED] to his sister's residence.

has been identified and made himself known as a DETECTIVE, Jackson County Sheriff's Patrol

HE HAS FULLY WARNED AND ADVISED ME, AND I KNOW:

1. That I have the right to remain silent and not make any statement at all, nor incriminate myself in any manner whatsoever.
2. That anything I say can and will be used against me in a court or courts of law for the offense or offenses concerning which this statement is herein made.
3. That I can hire a lawyer of my own choice to be present and advise me before and during this statement.
4. That if I am unable to hire a lawyer I can request and receive appointment of a lawyer by the proper authority, without cost or charge to me, to be present and advise me before and during this statement.
5. That I can refuse to answer any questions or stop giving this statement any time I want to.
6. That no law enforcement officer can prompt me what to say in this statement, nor write it out for me unless I choose for him to do so.

No one denied me any of my rights, threatened or mistreated me, either by word or act, to force me to make known the facts in this statement. No one gave, offered or promised me anything whatsoever to make known the facts in this statement, which I give voluntarily of my own free will and accord.

I do not want to talk to a lawyer before or during the time I give the following true facts, and I knowingly and purposely waive my right to the advice and presence of a lawyer before and during this statement.

I certify that no attempt was made by any law enforcement officer to prompt me what to say, nor was I refused to request that the statement be stopped, nor at anytime during this statement did I request for the presence or advice of a lawyer.

I have read each page of this statement consisting of _____ pages, each page of which bears my signature, and corrections, if any, bear my initials, and I certify that the facts contained herein are true and correct.

I spent the night at my sisters house and the next morning, June 30, 1971, I got up about 9:00 a.m. and my mom had called and told me that my scoutmaster, HARRY A. PALMER, was coming over to pick me up. He picked me up and we went to Jacomo where you shoot bows and arrows and were following the trails and shooting arrows and then we sat down on a log out there and he, Mr. Palmer, put his arm around me and he said "You want to go shooting some more" and I said "Yeah" so he goes -- well, he pulled my nuts, on the outside of my pants, then he said "Does it feel good" and I said "No". Then we went on with the other kids and there were about six of them. Then we went and took the other guys home and he took me back to my sister's house and this was about 2:00 p.m. Then we went out to the firing range the Independence Police Dept. firing range at Courtney Road and Kentucky Road and then shot some bottle rockets off and he took about three rounds of shells out of his gun. Then we went walking over to this one log. Then he put his arm around me and he was in back of me. I had on my blue jean shorts and they are real baggy and I didn't have a belt on. He kept saying for me to pull in my stomach, for about 15 minutes, and I said that I didn't want to.

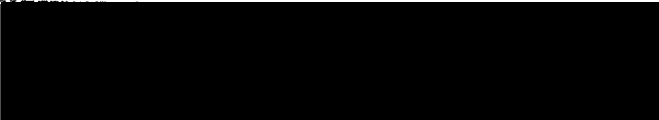
Then he said "see that gun over there?" and he put his hand down my pants and reached all the way down to the bottom and touched my penis and then I jumped up and said "I want to go now" and he said "O.K." and we picked up the stuff and left and he took me back to my sister's house.

Did you tell your dad about it?

Not until last week.
