Ex-Boy Scout leader sentenced

Judge imposes maximum 32 years for molesting two youths

A former Denver Boy Scout leader was sentenced yesterday to 32 years in prison for molesting two youngsters who were members of his troop.

[REDACTED] 42, was "very depressed" after the hearing, said Tamra Bowman, who defended him in Denver District Court. "The judge gave him the maximum sentence."

[REDACTED] was arrested by Denver police in November 1989 after a 19-year-old boy told authorities he had been molested since he was 9. Also [REDACTED] and child in Spaulding's Boy Scout

troop later said he had been molested over a period of three months.

[REDACTED] who has been in jail since his arrest, pleaded guilty to two counts of sexual assault and was facing a five- to 16-year prison sentence on each count.

Denver District Judge H. Jeffrey Bayless handed him two consecutive 16-year terms.

"I think it was a lot of years for somebody with a minimal criminal history," said Bowman.

Arguing for a lesser sentence, Bowman cited the lack of violence in [REDACTED] contact with the boys and the fact that he had supervised many

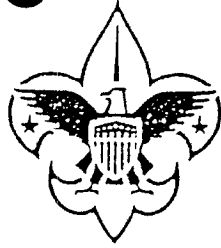
children without molesting them.

Bowman said that was evidence that [REDACTED] was capable of functioning "in a position of trust without abusing that" and, therefore, was a good candidate for rehabilitation.

"But the judge just decided he could not be rehabilitated," she said.

[REDACTED] "feels especially bad about the fact that he feels he shamed the Boy Scouts," and that boys in his troop had to be interviewed about a subject that undoubtedly was disturbing to them, Bowman said.

The sentence handed down against [REDACTED] "probably is a life sentence for him," she said.

Ex-Scout leader gets 32 years

Sex assaults on two boys violated trust, judge says

Former Denver Boy Scout leader Harry [REDACTED] yesterday was handed the maximum 32-year prison sentence for repeatedly sexually assaulting two boys who were members of his Scout troop.

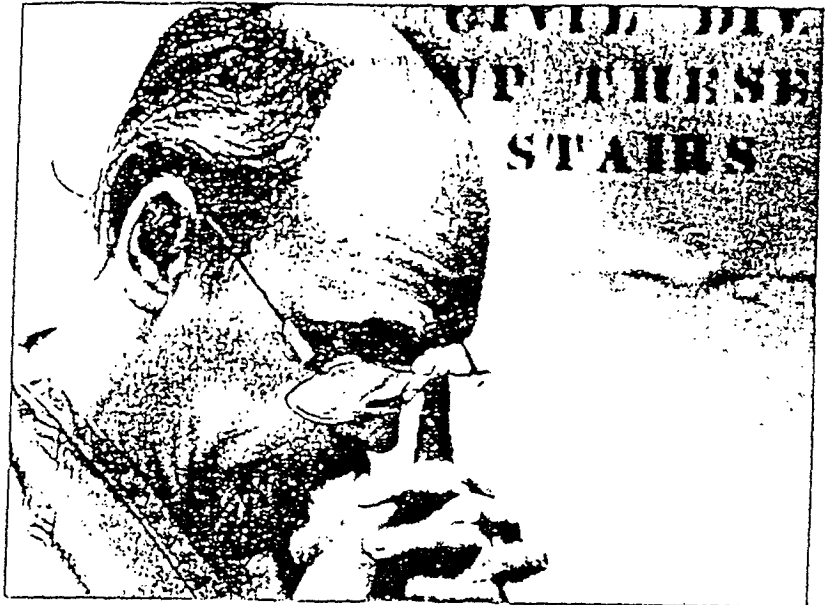
Denver District Judge Jeff Bayless, a former prosecutor, ripped [REDACTED] for violating his position of trust and casting doubt on an institution he described as "one of the finest traditions we have in this country."

"The Boy Scouts of America fall into a very small grouping in the eyes of American parents, akin to mom, apple pie and baseball," Bayless said.

[REDACTED] actions have made some parents reluctant to let their children participate in scouting "for fear other [REDACTED] are out there," the judge said.

[REDACTED] 42, molested one of the boys over nearly 10 years, from when the boy was 8 until he was 17. The other victim was molested during a three-month span.

"I don't believe the defendant can control his actions. His way of caring is a danger to young boys," Bayless said. "The oldest persons I see in this courtroom are pedophiles. Robbers and druggies stop. Pedophiles don't."

Ex-Scout leader gets 32 years for sex assaults

In return for [REDACTED] guilty pleas to two counts of second-degree sexual assault, the prosecution dropped five counts of sexual assault on a child. The dismissed counts alleged that [REDACTED] fondled two boys, 8 and 9, whom he was babysitting in late 1989.

Prosecutor Karen Steinhauser asked the judge for the maximum sentence, saying [REDACTED] misuse of his position devastated his victims and robbed them of their childhood.

"When someone uses their position — a Boy Scout troop leader and all that implies — to gain a child's trust, it is almost worse than a (sexual assault) case involving force and violence," Steinhauser said.

The prosecutor noted that the boy who was molested over the 10-year period had been persuaded to join the Scouts by [REDACTED] shortly after the youth's father died.

When the two victims were asked about an appropriate sentence, Steinhauser said, one wanted his executed and the other said he should go to prison for life.

The prosecutor said she visited with members of [REDACTED] Boy Scout troop and their parents, and they voiced an overwhelming sense of betrayal. "There are just so many people he betrayed."

One of the victims considered making a statement in court but decided it would be too painful.

Instead, the youth wrote the judge that he didn't think he could handle being near [REDACTED].

"The hurt is too much because not only did he abuse me physically but mentally as well," the victim said. "I would like to see Joe Spaulding get the maximum and then some, because I believe I would do it again, and I would want to have some other little boy go through what I did. Please don't let that happen."

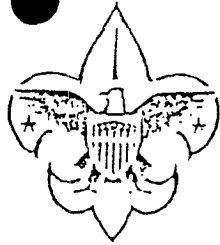

Ex-Scout leader enters guilty plea in sex case

One victim molested over 10-year period

Former Denver Boy Scout leader [redacted], 42, pleaded guilty yesterday to sexually assaulting two boys who were members of his Scout troop.

One of the boys, now 19, was molested over a 10-year period, prosecutor Karen Steinhauser told Denver District Judge Jeff Bayless. The other boy was molested over a 3-month span.

[redacted] met both boys through scouting activities, Steinhauser said.

Because of the aggravating factors surrounding the cases, including the duration of the one assault and because [redacted] was on probation for theft, the Denver district attorney plans to ask that [redacted] receive a maximum 32-year prison sentence.

Sentencing is scheduled for March 2.

"When you have sex abuse over a period of time it is in some manner going to affect the victim for the rest of his life," said Steinhauser, a chief deputy district attorney.

Steinhauser said that [redacted] spent considerable amounts of time with both victims away from scouting activities. In the case of the boy who was abused for a decade, [redacted] took the youth on outings and bought him things, Steinhauser said. In essence, the prosecution alleged, [redacted] became a guardian for the fatherless youth.

The other victim went camping and to concerts with [redacted], Steinhauser said.

In return for [redacted]'s guilty pleas to two counts of second-degree sexual assault, the prosecution agreed to drop five counts of sexual assault on a child.

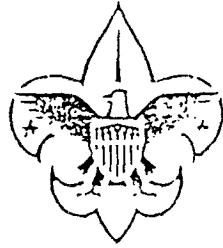
The dismissed counts alleged that [redacted] fondled two boys, ages 8 and 9, whom he was babysitting in late 1989.

Steinhauser said she agreed to a plea bargain because she didn't want to put the victims through any more trauma and because [redacted] still faces a lengthy prison term.

Bayless also will sentence [redacted] for theft from a Denver gas station.

He could receive up to 16 years in that case. Originally, under a plea bargain entered in June 1988, he had received a deferred sentence in which he would avoid a prison term if he stayed out of trouble.

His sexual assaults were violations of the plea bargain and authorities have asked Bayless to impose a sentence in the theft case.

It appears this is all we can do at this point. The Police Department has informed us that [REDACTED] fits the typical pedophilic profile and they have substantial evidence including photographs to put him away for a long time.



Ex-Scout leader held in sex case

A former Denver Boy Scout leader who is suspected of sexually assaulting at least one Scout for 10 years, has been arrested for investigation of sexual assaults on children.

Suspect linked to 6 counts of sexual assault

ing, 42, of Denver, was being held for investigation of two counts of sexual assault against a child and four counts of sexual assault in a case unrelated to his scouting duties.

He was being held on \$25,000 bond in the Denver County Jail yesterday.

"We've found one victim and we're fairly certain there are others," said Denver police Sgt. Robert Padilla. Police are questioning former members of the troop, which was not identified. The victim who came forward is now 19 years old and claimed the assaults began when he was 9.

Police did not know when [redacted] was a Boy Scout leader but think he headed a troop for at least 10 years.

Boy Scout officials could not be reached for comment yesterday.

Police became aware of the suspect when a woman called police Nov. 18 after her two sons, ages 8 and 9, had told her that their baby-sitter, [redacted] had inappropriately touched them, Padilla said.

The woman told police she had rented her basement apartment to [redacted] two months ago and that he was a former Boy Scout leader.

Detectives followed up on the Boy Scout tip, checked the troop he led and found an apparent victim, now 19.

"We made contact with one of the boys, and he did sexually assault him" during a 10-year period, Padilla said.

Other Scouts who were questioned said they had not been assaulted.

The woman also turned over to the police six or seven photo albums that she said she found while moving some of [redacted]'s possessions. The albums contained photos of naked men and boys, Padilla said.

"One of them was of the boy he knew through the Boy Scouts," he said.

Last year, the Denver Boy Scouts officials launched a program called Youth Protection Training that is aimed at warding off child molesters.

Aspiring scout leaders now have to list on their applications any drug, child-abuse or other felony charges they may have faced.

All leaders are forbidden from being alone with any child for any length of time. At least one other adult must be present at all times.

The program was launched to ward off child molesters who become scout leaders to recruit victims. Nationwide, there have been at least 100 accusations of sexual assault against scout leaders in the past decade.
