Thanks for your letter of August 14 and the copy of the registration application for Mr. Blauvelt. I am returning the original application for your file, so you can have this in case you need it for the future.

Our policy has been that we would not accept someone who has been guilty of child abuse of a sexual nature. We, therefore, feel that this application should be refused, since it is quite obvious that this was related to child abuse of some type.

If there is any question concerning this, the Kansas City Second Ward or Mr. Blauvelt could contact the national office. I would not want to vouch for anyone's cure in a matter of this type.

Thanks for asking about this since I think this is critical, and Mr. Blauvelt should not be registered with the Boy Scouts of America.

We would appreciate an Ineligible Volunteer Record Sheet, so that we have this information in our files should we need it in the future. A form is enclosed for your use.

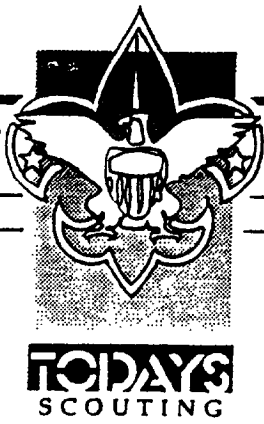

We are asking Mr. Blauvelt to serve as a Committee Member and to assist with campouts, summer camp, etc. In Section 6 of the attached "Adult Application", two questions were answered "yes". An explanation is also stated on the application for each question.

Mr. Blauvelt was very concerned about these blemishes on his record and came to me desiring counsel and direction as to whether or not to forward his application to your office for processing. As a result, he and I discussed in detail the facts behind his "yes" answers. I have his verbal permission to further discuss these matters with you. I trust you will maintain confidentiality as well.


I feel confident that there will be no problems relating back to question 6B. The offense was twenty years ago involving an altercation with an older brother and has not been repeated since. The brother now lives out of town.

However, the offense referred to in 6C has occurred much more recently. Therefore, I delved into that situation in more detail. Mr. Blauvelt completed a state mandated treatment program five years ago. He assures me there have been no more infractions since that time. The child involved has married and lives out of the state. He understands the seriousness of the violation and practices the control techniques learned in the treatment program. I believe there will be no problems as he works with young men in Scouting.

Should you have any questions, do not hesitate to contact me. The last thing I want is to have a scout leader or chaperon perpetrate any kind of deviant act with our young men. I am confident that Mr. Blauvelt will maintain his self-control.

Thank you for your help in this matter.
