STATEMENT

REF: HOWARD GOEI

June 12, 1991 9:30 p.m.

I phoned two members of the Troop 352 Committee, Eugene J. Schmidt, registered as C.R. and Richard J. Hatkowski, the Committee Chairman. Both attended the activity in Canada with Mr. Goei and both related the same sequence of events.

Troop 352, while attending an International Camporee in Ontario, Canada, were requested to demonstrate a culture activity at "See and Do" Station, a part of the camporee program. The troop decided to demonstrate a New York-type chorus line dance. The activity seemed to be well received because many Scouts throughout the encampment were continuing the dance after the event.

At a later time, Mr. Goei was approached by the O.P.D. He was informed a girl had reported he touched her breast during the dance. The police stated the girl had problems before at home. The police made no arrest. There was no additional action taken in the matter. In light of the accusations the leaders decided to discontinue the activity.

Howard Goei is the father of [REDACTED], a new 11 year old Scout in Troop 345. He is not a registered leader but has been known by the two Scouters I spoke with. They both considered him a man of good integrity and were actively recruiting him as an adult in their troop.

Further to our telephone discussion I am sending the information regarding Howard Goli.

Howard was involved with a Regional Camporee near Sudbury, Ontario. He was investigated by the Ontario Provincial Police regarding fondling the breast of a 13 year old Canadian Girl Guide. After the investigation the charges were dropped. I am not aware of any action that Girl Guides may take.

The Police suggested that we make you aware of the incident and they have indicated that the incident was in all probability an accident. Our information is that Howard Goli lives at [REDACTED] South West Wyoming, Michigan. We were not given group or district information.

This is all the information we have and we hope it is not the start of a problem.
