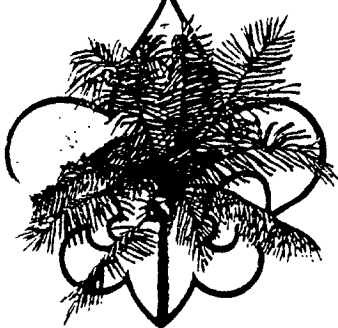

Pursuant to your request, I am writing this letter to inform you of the status of the above mentioned case.

The law requires that in order to convict any person of a crime, the evidence must establish that persons guilty beyond a reasonable doubt. After reviewing all of the facts, circumstances and evidence presented in this case, and the investigation conducted by the Miami Beach Police Department, Chief Assistant State Attorney Abraham Laeser and I have determined that there is an insufficient amount of credible, admissible evidence to establish Irving Schoenfeld's guilt beyond a reasonable doubt. Accordingly, at this time, we are unable to file charges against Mr. Schoenfeld. We have also concluded our investigation.

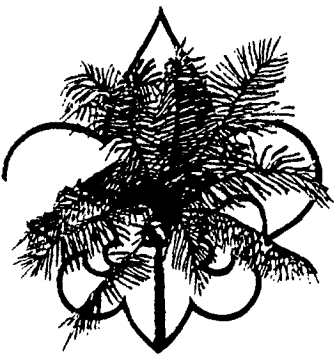
