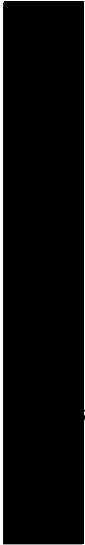

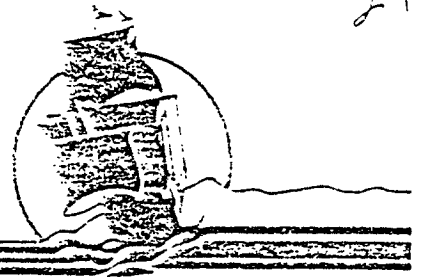

To Whom It Concerns -

Soon after I married [redacted] on March 31, 1984 - he told me of sexual abuse he was a victim of at the ages of 12 and 13.

The man who sexually abused [redacted] was a "trusted" scout master - Reed Diddle. [redacted] was from Eugene, OR and Reed had been, too but moved to Idaho - in or near Nampa. For summers [redacted] parents sent him to Reed to learn the art of cabinet building - Reed is a cabinet builder.

During these summers (one or both) Reed slept in [redacted] bed with him and sexually abused him ... to what specific acts - I am unsure. [redacted] told me that Reed's wife walked in on ~~one~~ the two of them in the process of these acts, yet the abuse continued.

Though [redacted] admits to being a victim of this abuse man - he denies the rest of what he told me earlier. The rest is that [redacted] abused the scoutmaster's, then infant, son while babysitting him.

Myself and our three children have suffered extensive physical, sexual, mental / emotional abuse at [redacted] hands - this past sexual abuse of [redacted] is definitely a major factor. The chain must be broken !!!

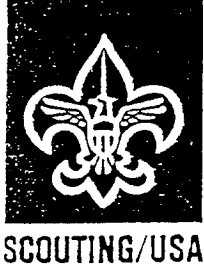

SUBJECT: Morals Allegations

A Mrs. [REDACTED] [REDACTED] called today to report a morals allegation.

Her son-in-law and daughter are involved currently in divorce proceedings. During the proceedings the son-in-law alleged that his abusive behavior may trace back to an extended period of molestation as a youth by his Scoutmaster.

Mrs. [REDACTED] identifies the Scoutmaster as one Reed (or Reid) Dowdle, then of Eugene, Ore., some 10 years ago. She says that Dowdle subsequently moved to the Boise area of Idaho, then to Jordan, Utah, and is currently in the Boston area. He apparently continued as a BSA volunteer in Idaho and Utah; she does not know whether he is now registered.

She says that he was associated in some way with the man in Eugene who has recently been convicted.

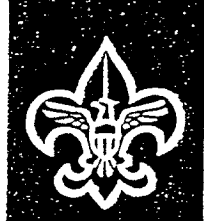
The son-in-law (above) is identified as [REDACTED]

She believes the BSA, now having been "formally notified", should prohibit Dowdle from further BSA activities if he is, indeed, registered. She is quite willing to provide additional substantiation for her allegations.
