IT IS ADJUDGED that the defendant has been convicted upon his plea of nolo contendere to the offense of Sexual Abuse of a Minor in the Third Degree, as charged in Count II of the Indictment, in violation of A.S. 11.41.438, and the court having asked the defendant whether he had anything to say as to why judgment should not be prenounced, and no sufficient cause to the contrary being shown or appearing to the court,

 $\,$ IT IS ADJUDGED that the defendant is guilty as charged and convicted.

It appearing to the satisfaction of this Court that the ends of justice and the best interests of the public, as well as the defendant, will be served thereby,

IT IS ORDERED that the imposition of sentence be suspended for a period of two (2) years, and the defendant is placed on open probation to the Court for a period of two (2) years. Throughout this period of probation the defendant is to remain on good behavior, and is to abide by all conditions contained in the Plea Agreement filed on the 2d day of May, 1986.
