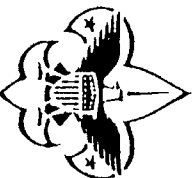


In response to your letter of September 28th, I can offer you the following information on the case of Jack Sewell.

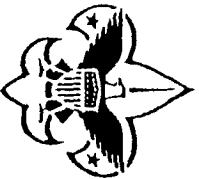

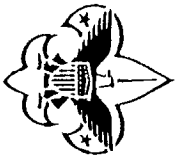
