Sex crime admitted to judge

Ex-circuit clerk pleads guilty

JEFFERSON CITY — Jack Roberts, former Clay County circuit clerk, pleaded guilty here Friday to a felony charge of deviant sexual conduct.

Roberts, 55, had been charged with one felony and two misdemeanor sex charges, all involving young boys. Under an agreement reached between prosecutors and his attorneys, Roberts pleaded guilty to the felony charge, and the two misdemeanor charges were dropped.

Sentencing by Cole County Circuit Judge Byron Kinder will follow a pre-sentence investigation. Roberts could be sentenced to one to seven years in prison and be fined up to \$5,000.

Roberts was circuit clerk from March 1978 to March 1988, before resigning amid an investigation into the allegations of sexual misconduct.

After his resignation, Clay County Prosecutor Michael Reardon did not charge Roberts with the crimes, but put him in a diversion program for sexual offenders.

Under the terms of the diversion program, Roberts was required to stay away from boys under age 18.

Later, however, two witnesses said they saw Roberts sitting near a group of Boy Scouts at a Royals game. Roberts is a former scoutmaster.

After those reports, Roberts' probation was revoked, and a Clay County grand jury took up the investigation.

He was indicted on the three counts by a Clay County grand jury in August 1988. The incidents cited by the grand jury took place late in 1987 and early 1988, according to the indictment.

Also, after his resignation, state auditors criticized several actions taken by Roberts while he was circuit clerk, including taking money from county funds to buy bakery goods, meat and tableware and six poinsettias. More than \$90,000 was also apparently spent without proper bids being taken, auditors said.

Roberts appeared with his attorney, Michael J. Svetlic, and indicated he understood the arrangements of the plea bargain and admitted his guilt on the felony count, which involved a 14-year-old boy.

SUBJECT: SEXUAL ABUSE CASE

I. THE INCIDENT

On January 8, 1988, I received a phone call about a Boy Scout from Troop 373 (Liberty, Missouri) who stated a boy been sexually abused by a Scout Leader in 1982. This allegedly happened on a campout at Earnest Shepherd Memorial Youth center in Liberty, Missouri in the boy's tent. The boy, [REDACTED], is now 18 years of age and out of Troop 373.

I was also later informed by another person this man had abused a neighbor and other cases were under investigation.

The man has not been arrested, however, his investigation has been reviewed by a judge in Clay County. The Liberty City Police Department is investigating the man. The Clay County Juvenile Justice Office is aware of at least two allegeded abuse cases by Jack Roberts.

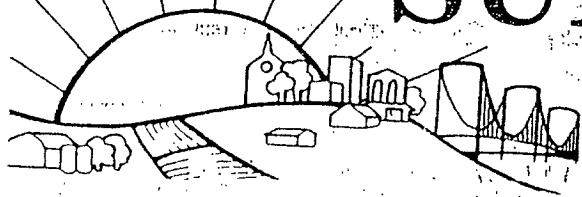
- II. JACK ROBERTS' BACKGROUND

The leaders name is Jack Roberts of [REDACTED] Missouri, 64068. He is in his 50's and has a full gray beard. Jack holds the Silver Beaver Award and Award of Merit. He serves on Camp Staff at H. Roe Bartle as a Campsite Commissioner. He is currently registered with the District Committee of North Star. He also has been a leader in the following troops in Liberty, Missouri:

- Troop 372, Methodist Church, Liberty
- Troop 374, First Presbyterian Church, Liberty
- Troop 320, Liberty Christian Church
- Troop 373, City of Liberty.

He is a Merit Badge Counselor. Currently Jack is the Clay County Circuit Clerk. He is a Board Member of Earnest Shepherd Memorial Youth Center.

Clay Official Resigns, Sexual Misconduct Alleged

Clay County Circuit Clerk Jack Roberts resigned from office after being accused of sexual misconduct with teenage boys. Prosecuting Attorney R. Reardon stated Roberts, 54, had issued a statement of resignation from office and would be out on a two-year probation after extensive psychiatric evaluation as part of a deferred prosecution program. According to Reardon, Roberts, Circuit Clerk since 1978, successfully completes his probation charges will be filed in court. This program, however, is not supervised by any court. Controversy about use of the deferred prosecution developed last Sunday, however, when County Sheriff Jack Corum said that Roberts' punishment was too lenient. "I feel Jack Roberts is getting preferential treatment," said Corum. "A normal procedure would be to file a complaint, issue a warrant, set bond and a court date. Corum said the deferred prosecution was inappropriate in this case. "Deferred prosecution has not been a standard procedure that I know of. In family cases involving incest they do this, but this is not that type of case." Reardon stated Monday that deferred prosecution was best for both the people of Clay County and the victims. "In this case the victims did not come forward; they were sought

out," said Reardon, who believes it is in the best interest of victims to keep their names confidential. Reardon also stated he did not want to put the county in the position of having an accused sex offender holding office during an investigation and trial. "He (Mr. Roberts) is not a friend of mine. We have not socialized. Our only contact is at the courthouse," said Reardon. "This man is a first offender. The charges against him were misdemeanors." Reardon stated what Roberts is facing now is the same thing as first offenders face when they are placed by the courts under supervision of the Department of Probation and Parole. "The sheriff's job is to catch them. My job is to decide what to do with them," concluded Reardon. "I hope all this is not politically motivated." Both Reardon and Corum claim to have asked for a grand jury investigation. Reardon reported he had asked Judge McFarland of the Circuit Court for an investigation on the Wednesday before Robert's arrest. Corum stated he had asked Circuit Court Judge Pratt for a grand jury investigation after learning Roberts had been placed on deferred prosecution. According to Sheriff Corum, Roberts had been under investigation since early December. "We began an investigation and talked with victims which

resulted in a number of statements," says Sheriff Corum. "At that point we requested a criminal warrant for deviant sexual assault." According to Reardon the evidence collected by Corum was enough to have Roberts arrested and brought in last Thursday. He was then released in custody of his lawyer, Mike Svetlic. After several more hours of negotiation Roberts' lawyer agreed to the terms of deferred prosecution. Reardon stated Roberts is now in a mental institution. "I don't know where he is," said Corum. "We have not been able to have a victim come forward before now." Officials have requested the name of the victim be withheld so as not to interfere with their investigation. The identity has been confirmed. Officials confirmed Monday that the victim coming forward with the allegations is a 28-year-old Liberty male, who claims Roberts had sexually abused him 13 years ago. The victim stated that he was at

that time a 15 year old and working for Mr. Roberts at the court house. Interviewed Monday he claimed Roberts had shown him pornographic material, offered him alcohol and then sexually abused him. "One day he brought a porno magazine to work. We looked at it while I was on a break, and then he brought some wine and I got drunk," he said. When asked why he told authorities about his relationship with Roberts, "I don't know, I wanted revenge all this time. I finally got it, and I don't feel any better." "I feel degraded. I guess I know my name is ruined in this town. I hope it never happens to anybody else. Maybe it will make other boys come forward before it's too late. I never told anybody, I wouldn't have told them if they hadn't asked me. It's just my own opinion. They have molested me since I was getting two years." According to Corum, the victim's accusations had been verified and had led them to obtain information from at least three other males.

Deputy Circuit Clerk Janice Groom has been appointed temporary Clerk by Circuit Court Presiding Judge Stephen R. Pratt until an interim director can be selected by Governor Ashcroft. Board of Election attorney Doug Noland stated that Robert's position which runs to Jan. 1 would most likely be filled in the November election. Filing for the Primary election in August will begin March 29. Both the Democratic and Republican central committees will be submitting names to Governor Ashcroft for an appointment to the position. Roberts owned an insurance and real estate company before joining the county clerk's office in 1966. He was appointed Clay County Circuit Clerk in 1978 to replace Edward J. Wnuk, who died that month. New allegations have arisen that trust funds handled may have been improperly used.

Grand jury to review Roberts' case

A Clay County grand jury is expected to meet today to probe allegations of sexual misconduct by former Clay County Circuit Court Judge Stephen Pratt.

Pratt resigned his post Friday in a letter to Circuit Judge Stephen Pratt following Roberts' arrest by sheriff's deputies Thursday afternoon at the Clay County Courthouse. Roberts had been circuit clerk since 1978. His resignation becomes effective today.

Sheriff Jack Corum asked for the grand jury after learning that Pro-seal Attorney Michael Rcardon had approved a request by Roberts' attorney, Michael Svetlic, for Roberts to enter a diversion program to avoid prosecution. Judge Pratt agreed Friday to convene the grand jury.

Corum could not be reached for comment Monday morning, but according to published reports, the sheriff department's investigation centered on alleged homosexual conduct by Roberts involving juveniles. Roberts has been involved in the Boy Scouts in Liberty.

The investigation began two and one-half months ago after a Clay County Jail inmate apparently acquainted with Roberts, made a statement to sheriff detectives. As a result of the tip, authorities obtained information from four other males.

Under a signed agreement, contingent on Roberts' resignation, he would be placed in a diversion program for up to two years. If he successfully completes the program, no charges would be filed. The program is similar to probation and includes counseling and supervision by Missouri probation authorities.

The office's chief deputy clerk will take over Roberts' duties until Gov. John Ashcroft appoints an interim circuit clerk. An election for the remainder of Roberts' term, which runs until 1990, will be held in November.

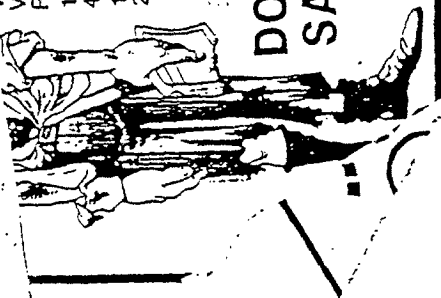

Our View...

Never ending tragedy

The sad case of Jack Roberts has been a difficult one to report.

It is difficult, not because we knew Jack Roberts, but because we didn't really know him. We only knew the side of him he projected to the public. The other side of Jack Roberts was evil and manipulating, as today's front-page exclusive interview with one of his victims reveals.

Nobody will ever know whether Jack Roberts' crime 13 years ago, his molestation of Rich Vanzant, had anything at all to do with Vanzant's alleged November kidnapping and molesting of a 13-year-old Liberty High School girl.

But it seems possible that it did have something to do with it. And that is the saddest commentary.

Jack Roberts' crimes, whether he is punished for them or not, will never be erased. The scars he has left behind, on the possible hundreds of children and young adults he molested, will last much longer than even Roberts.

How many others will feel the effects of his crimes, it is impossible to say.

But it is fair to say that the Jack Roberts incident is not over. It never will be. Not as long as his victims, and their victims, live.

Roberts is now getting counseling, at the expense of the taxpayers, but his victims are left to fend for themselves - to try to work out on their own why what happened to them happened.

Roberts' crime, in some minds, was no less heinous than Vanzant's. But Roberts was much better at it. He didn't need a gun. He used his wits to seduce his victims. And because there was no "violence," Roberts gets a slap on the hand.

Vanzant won't. And he shouldn't. And neither should Roberts.

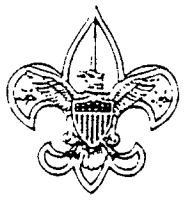

March 1978 and later ran successfully for the post. Before that, he had served 12 years as chief deputy clerk.

Reardon said Saturday that the investigation began about 2½ months ago through information from a Clay County Jail inmate. The inmate, who apparently was acquainted with Roberts, is a Liberty man charged with kidnapping, attempted rape, armed criminal action and four counts of sodomy in a case involving a Liberty girl.

Officials said they later obtained information from four other males as a result of that tip. Authorities said Roberts gave a statement about the cases under investigation.

Reardon declined comment about what Roberts said, but he said "for a diversion program, we require an admission" of wrongdoing.

Pratt said Saturday that he requested an auditor from the state court administrator's office to examine records in Roberts' office. But Pratt said "nothing of any significance" was found during the examination Friday.

Corum said Saturday that authorities found a loaded .22-caliber revolver in Roberts' desk. He said Roberts gave the department permission to take the gun.

Clay County officials changed locks on four doors in the circuit clerk's office and computer room Friday, the day Roberts' resignation letter was submitted, said Clay County Administrator Walt Van Asselt.

Van Asselt said the actions were "normal security precautions" to protect data on the computer system.

Clay County Circuit Judge Stephen Pratt agreed Friday to convene the grand jury Wednesday at Corum's request. County judges selected names Friday for the grand jury, and deputies were to serve summonses, authorities said.

Corum said it was the first time since he was elected in 1976 that he had called for a grand jury.

The unusual nature of Corum's action was reflected by Homer Foote Jr., sheriff of Cass County, who said, "I've never heard of such a thing."

He and Tom Thomas, Platte County sheriff, said they knew of no other case in which a sheriff had called a grand jury without working through the prosecutor's office.

Reardon declined comment Saturday on Corum's call for the grand jury, although he briefly discussed other aspects of Roberts' circumstances.

Roberts, 54, the circuit clerk since March 1973, submitted his resignation less than 24 hours after his arrest. He was unavailable for comment Saturday. Officials said he had already begun the counseling program.

Roberts' letter said the effective date of his resignation was March 16.

Pratt said Saturday he understood that "one of the reasons the prosecutor and defense attorney made the deal was so he (Roberts) could get his retirement. The reason he made it Wednesday was so he could get his 10 years in."

Roberts' attorney, Michael J. Svetlic, declined comment Saturday. Reardon said Saturday, "I don't know what his retirement situation is."

Clay County Eastern Commissioner Bill Kersten said Saturday that all three commissioners had discussed the case after learning about it Thursday.

"There were questions about the lack of arraignment by the prosecuting attorney," Kersten said. "We wanted to know the reasoning for his position."

Grand jury to probe clerk's case

Clay County Sheriff Jack Corum is getting preferential treatment after an arrest in a sexual misconduct case, has taken the unusual step of calling a grand jury.

A county grand jury typically is convened by a circuit court judge at the request of a county prosecutor. In this case, however, Corum went to the Circuit Court and asked for the inquiry which was approved.

Corum opposes the decision by Clay County Prosecutor Michael Reardon to allow Clay County Circuit Clerk Jack I. Roberts to enter into a diversion program.

Roberts was arrested Thursday night after a sheriff's investigation into a alleged homosexual conduct with juveniles.

He resigned, effective Wednesday and asked to enter a diversion program and undergo counseling. If he completes the up-to-two-year program successfully, he would not be charged.

"He's getting preferential treatment," Corum said, contending Saturday that sufficient evidence exists for Roberts to face criminal charges in court. Corum also said he wants the grand jury to probe accounts in the circuit clerk's office.

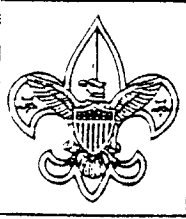
