# Priest ordered to prison

## He molested boy in rectory

A Catholic priest was sentenced Friday to one to five years in prison for sexually molesting a teen-age boy in the rectory of the Overland Park church where he served as associate pastor.

The Rev. James A. Forsythe made an impassioned plea for probation to allow him to be treated at a church-run facility in New Mexico for priests with psychosexual problems.

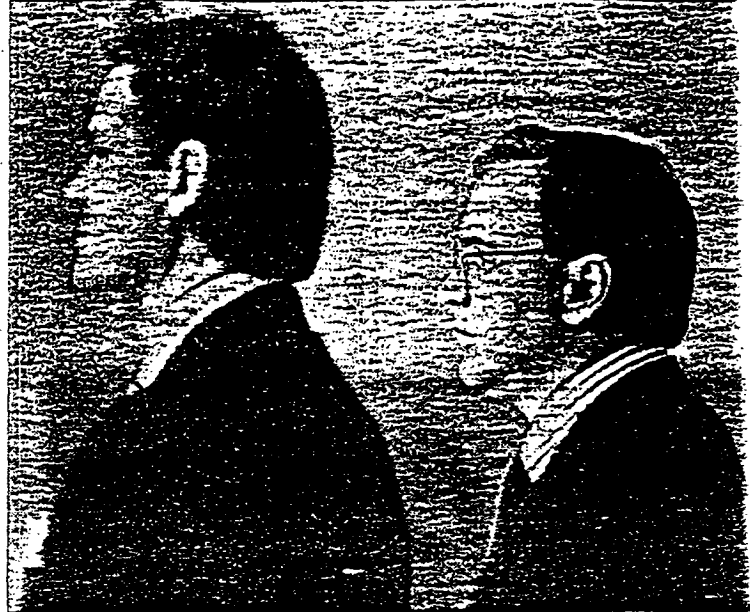
But Johnson County District Judge Gerald Houglund denied the request and ordered Forsythe into custody.

Houglund said he would reconsider probation for Forsythe after the priest is evaluated for 120 days at the Kansas Department of Corrections' Reception and Diagnostic Center in Topeka.

Forsythe, who served as associate pastor of Holy Cross Church in Overland Park, pleaded guilty Dec. 3 in Johnson County District Court to a charge of attempted indecent liberties with a child.

Forsythe admitted at that time

that he had sexual relations with the boy about 20 times between May 1987 and May 1988.—

At Friday's hearing, Assistant District Attorney Tom Bath said Forsythe had sexual relations with at least three other youths in the last seven years.

"The incident with this boy, who was about 15 at the time, is not an isolated incident," Bath, arguing against probation, said of the case in which Forsythe pleaded guilty.

Forsythe, 35, was assigned to the church, 3511 W. 93rd St., about two years ago.

Police first became involved in the case in November. Forsythe voluntarily gave up his duties at that time. He has since had his priestly privileges withdrawn by the church, according to his attorney, Scott Kreamer.

Forsythe cannot be reinstated as a priest until he successfully completes the inpatient counseling program operated by the Servants of the Paraclete in Jemez Springs, N.M.

The program, which normally runs for five months, provides psychological and spiritual help for Catholic priests suffering from psychosexual problems. The facility has been operated since 1947.

Kreamer noted for the judge the numerous letters of support for Forsythe he has received, and he pointed out that even the victim's family hoped the priest would be placed on probation.

"Either he will be cured or he will

lose his priesthood forever. Kreamer said of Forsythe's future.

Forsythe told the judge he wanted to continue serving the community as a priest. He said that he thought he could defeat his problem and that he had a lot to offer the community.

Forsythe apologized to the teen-age victim and others who may have been hurt by his actions.

"I truly believed what I was doing was showing him the love and affection he needed," Forsythe said. "I did not realize I was trying to meet my own needs."

Forsythe said he had struggled with his own sexuality for years and now realized that he needs help.

"I know that I have a problem and I don't like that problem," he said. "I know I need help."

In denying probation for Forsythe, the judge said "the court cannot treat you differently."

"A child molester is a child molester and must not be dealt with differently based on education, social standing or vocational qualifications," Houglund said.

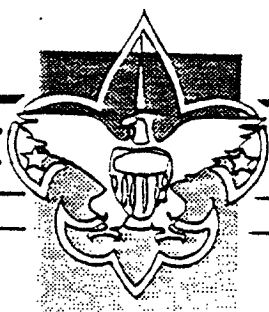

# Priest is guilty in sex case

## He tells court he took liberties with teen boy

An Overland Park Catholic priest pleaded guilty Friday in Johnson County District Court to attempting to take indecent liberties with a child.

The Rev. James A. Forsythe of Holy Cross Church admitted in court he had sexual relations with a teen-age boy about 20 times between May 1987 and May 1988.

"Yes, sir," Forsythe answered when District Judge Gerald Hougland asked him if the allegations were true.

Assistant District Attorney Tom Bath said the encounters between Forsythe, 35, and the teen-ager occurred in the rectory of the church, where Forsythe served as associate pastor.

In October, an area therapist reported information about possible misconduct by Forsythe to the Kansas Department of Social and Rehabilitation Services, Bath said. Overland Park police were notified and on Nov. 14 detectives interviewed Forsythe, who admitted to the encounters with the youth.

Forsythe had been assigned to the church at 8311 W. 93rd St. for about two years. The church's pastor, Father Anthony Lickteig, said Forsythe asked to be relieved of his duties in November.

Forsythe first was charged with the more serious crime of taking indecent liberties with a child, but the charge was reduced as part of the plea agreement.

Bath and Forsythe's attorney, Scott Keener, jointly agreed to recommend the minimum sentence of one to five years in prison.

Hougland, however, told Forsythe that he was not bound by the plea negotiations and could sentence the priest to the maximum sentence of three to 10 years and fine him up to \$10,000.

The judge ordered a presentence investigation and scheduled sentencing for Jan. 11. Forsythe will remain free on a \$3,000 personal recognizance bond.

The only comment on the case by local church officials was a statement issued by Archbishop Ignatius J. Stecker of the Archdiocese of Kansas City in Kansas.

"I am deeply saddened by the actions of Father James' Forsythe that have led to a legal charge in the local courts," the statement said.

"To his credit, recognizing his problem, Father Forsythe sought counseling and through that process has admitted to an offense.

"God's wondrous gift of human sexuality is made beautiful in the holy bonds of marriage. On the other hand, it loses its beauty and is sinned against when it is offered in or outside of marriage. It is all the more so when the offender is someone as trusted as a Catholic priest.

"We reach out with sympathy and compassion to the young man victimized by his actions and to his family. They rightfully deserve their privacy. Our prayers are with them.

"Upon learning of his offense, Father Forsythe was immediately released of his assigned duties in the church. He is being provided the best professional in-service counseling and evaluative services."

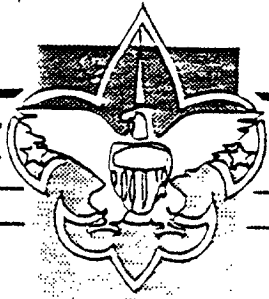

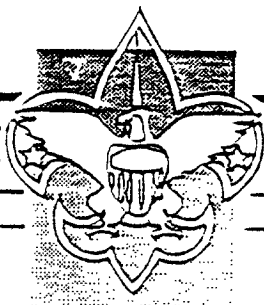

The boy, now 16, was 15 at the time of the alleged abuse, Detective Jesse Rollwagen said. The incident reportedly took place in Overland Park.

The Rev. Anthony Lickteig, pastor at Holy Cross, said Forsythe was assigned to the church about two years ago and asked to be released from his duties a few weeks ago.

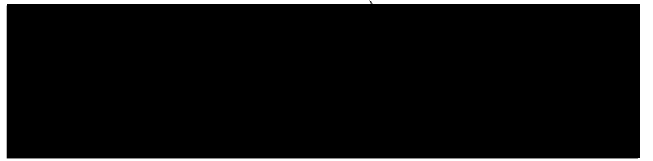
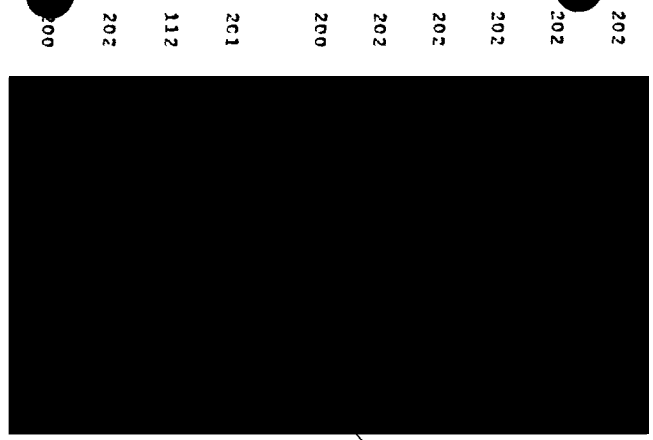
