AGREED ORDER OF REMAND


Come the District Attorney General for the State of Tennessee and the defendant, by and through his attorney, David Stuart, and move the Court to remand the above-styled case to the Oak Ridge City Court for disposition for the following reasons:

- 1) It is a late reported offense (it occurred in August 1983 and was reported in January 1984).
- 2) The one witness to the offense (the victim) is of questionable credibility.
- 3) Defendant has agreed to plead guilty to child abuse in the court below.

Therefore it is ORDERED by the Court that the above-styled case be remanded to the Oak Ridge City Court for disposition as agreed by the parties; and any Circuit Court Clerk fees may be added to the costs of the cause.



ORDER
