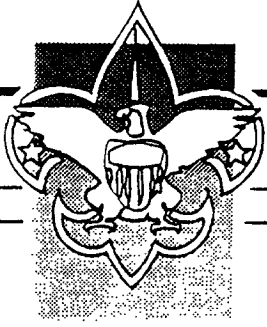

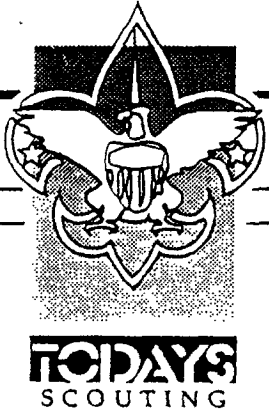

We have removed Mr. Street from our membership file and placed his records in a confidential file. We will keep you advised of further developments.

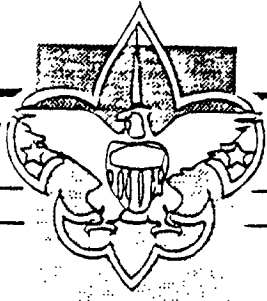

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand the BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

She also alleges that Dennis Street had anal intercourse with the same group of boys. She alleges Dennis gave the boys alcohol and perhaps (Butyl Nitrate?). These activities also allegedly took place in her house.

[REDACTED] said that [REDACTED] and [REDACTED] mother were in possession of laparoid pictures of various sexual acts. He also stated [REDACTED] his mother and [REDACTED] were going to the police this afternoon.

Her sons name is [REDACTED] and is registered in John Olverus troop. Dennis is also registered.
