James H. Williams, date of birth April, 19~~8~~⁵; race white; sex male; drivers license number South Carolina [REDACTED], expired 1989; married; social security number [REDACTED]; approximately 150 pounds; 5'7"; hair black. The naval investigation resulted in a discharge of convenience during the time of the investigation he was a confessed homosexual and at this time has supposedly moved back to South Carolina.

This is all the information we were able to acquire from the naval investigation.

Dear Mr. Williams,

In response to your request of 04Oct89, our office is currently conducting an investigation into possible child sexual abuse and homosexual activities by James H. Williams. This investigation originated after numerous male homosexual pornographic magazines, books and a movie were discovered in Mr. Williams' desk, which was subsequently seized by the NIS. Also discovered in Mr. Williams' possession were numerous Polaroid photographs depicting Mr. Williams and various teenage boys in the nude engaging in self-masturbation, as well as alcohol consumption by the teenage boys. During a subsequent interrogation, Mr. Williams admitted that the abovementioned items were his, and the pictures were taken during 1980-1981 in South Carolina. Williams stated the photographs included his adopted son, [REDACTED] who was about age 12 at the time of the photographs, and several of Gary's friends. Williams denied engaging in any sexual acts with these boys, but did admit to providing them with alcoholic beverages. Williams admitted he enjoys reading homosexually oriented material and that he becomes sexually stimulated when reading it. However, Williams denied engaging in any homosexual acts. Williams stated that as an adolescent in the Boy Scouts, he had participated in masturbation "circle jerks," but that was the extent of his participation in such activity.

The U. S. Attorney's Office in Memphis, TN, has been apprised of this investigation. Our investigation is continuing as Mr. Williams' activities are typical of the pedophile profile, and homosexuality is a violation of U. S. Navy policy. We do not presently have any information indicating that Mr. Williams has any previous convictions, nor do we have any information indicating he may have sexually abused any Boy Scouts here or elsewhere.

Due to Privacy Act requirements, we cannot release Mr. Williams' Social Security Number without his authorization.

We will attempt to keep you apprised of any developments in this case which might be of interest to the Boy Scouts.

FILE ON JAMES H. WILLIAMS

August 25 - David Williams received a call from Vern McCarver (Navy Criminal Investigative Dept.) that they were investigating James Williams concerning child pornography and homosexual activity. They had confiscated material from his home that supported evidence on both counts. He said he would stay in touch with any further information.

August 28 - [REDACTED] (SM T-66) was contacted and told of the accusations made about James Williams. [REDACTED] was told that James Williams was to no longer be involved in any Scouting functions.

August 30 - David Williams and John Page personally delivered a letter to James Williams stating that his registration with the Boy Scouts of America was being terminated and he was to have no further involvement in any with the Scouting program. An appeal could be made to the council if he so desired.

August 30 - Vern McCarver was asked to send us a letter stating what, if any, charges were being filed against James Williams and what agencies had been notified concerning their investigation. He stated a letter would be sent in one or two weeks.


Dear Mr. Williams:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.
