Counselor Faces **Assault Charges**

NORTH STONINGTON - State police arrested a Hartford man Monday night at the camp where he is a counselor and charged him with sexually assaulting a 13-year-old boy.

Lt. Kenneth H. Kirschner, a state police spokesman, said James K. Robertson, 43, of 600 Asylum St., was being held on a \$20,000 bond at the Montville barracks on one count of second-degree sexual assault, four counts of risk of injury to a minor and three counts of fourthdegree sexual assault.

Kirschner said the boy's family complained to police July 19 that the boy was molested in incidents from July 11 to July 18 at Lake Isles camp.

Kirschner said Robertson spends summers working as a counselor at the camp, and is a commissioner of Boy Scout Troop 75 in Hartford. Robertson is scheduled to be arraigned in Superior Court in New London today.

Scout Leader Freed on Bond

A Boy Scout leader from Hartford, who has been accused of sexually assaulting a 13-yearold boy, was freed Tuesday on \$5,000 bond.

James Robertson was arrested Monday night at the Lake of Isles Boy Scout Camp in Preston and

charged with second- and fourthdegree sexual assault and risk of injury to a minor, state police

said.

Robertson, 43, a scout leader and summer counselor at the camp, was held Monday night in the Montville Barracks and was arraigned Tuesday in Superior Court in New London, state police said. He is scheduled to appear in court July 30.
