August 29, 1989 - Met with James Neff at Columbia Gas Co. David Frost, Council President and James Stone, Scout Executive read letter to Mr. Neff suspending his registration with the Boy Scouts of America. We also gave him a copy of the appeal procedure and a \$7.00 check refunding his registration fee.

He indicated that he was sorry for what he did and wished that the film had been available ten years ago. He also indicated that he never had much of a family and that Scouting was the only family he ever had.

Mr. Neff endorsed the check and returned it to me and indicated that he would not appeal the suspension. Mr. Frost encouraged him to seek the help he needed. Mr. Neff departed in tears.
