with sexual abuse*

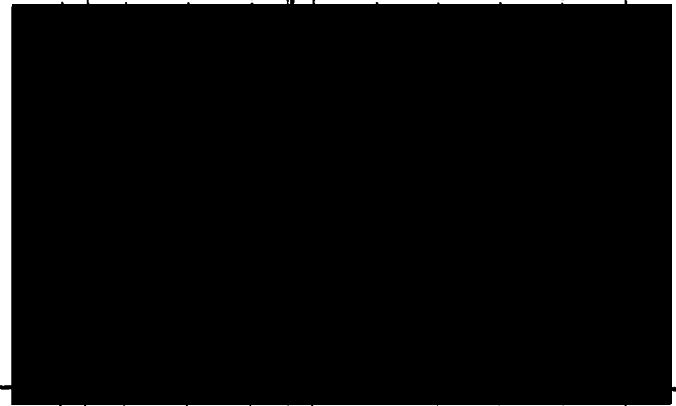
James L. Jasper, 38, 959 S. 27th St., has been charged with second degree sexual abuse in connection with an alleged incident in August.

He pleaded innocent in magistrate court Wednesday and requested a preliminary hearing which was set for Jan. 11 at 11 a.m. He was released on his own recognizance with supervision by the Department of Correctional Services.

The information charges Jasper with "prohibited sex act with a female child...under the age of 12."
