Would you please remove the name of James Philpott, Scoutmaster of Troop 348, from your files and send us the necessary information for putting him on the confidential list.

We ran into a situation here where Mr. Philpott was practicing sexual perversion. The matter has come before their Troop Committee and they asked him to resign. He has turned over his registration card to me and all of his material to the troop.

Since this action was taken by the Troop Committee, Mr. Philpott tried to take his own life and he is now in serious condition in a local hospital.

Undoubtly the man needs psycho treatment and being a veteran he will be moved to the veterans hospital as soon as possible where medical and psychology treatment will be given to him by the government.
