He was arraigned before District Justice Plancy Hamill and committed to prison to lieu of \$80,000 bail.

A cording to newspaper records. Morrisco was convicted in a jury trial lest May of sexually assaulting a 14-year-old boy between June 1082 and Flay 1995.

Merrison was convicted of state police charges of statutory rape, involuntary deviate sexual intercourse, corruption of minors and indecent assault.

Morrison, who has yet to be sentenced on the May conviction, according to court records, was free pending the appeal of the verdict before a higher state court.

A Stevens R2 man has been convicted by a Langaster County Court jury of statutory rape and sexually assaulting a 14-year-old

James R. Mortison, 34, was, charged by Ephrata state police Trooper William Henry with as-saulting the teen-ager at various times between June 1982 and May 1985.

Morrison will be sentenced at a later date on his convictions for statutory rape, involuntary deviate sexual intercourse, corrupting minors and indecent assault.

The trial was held in the courtroom of Judge Ronald L. Buckwalter. Defense attorney William Wheatly made oral motions in account of the court of the tions in arrest of judgment and for a new trial. Assistant District Attorney Mary Lou Barton was the prosecutor.



It has been a long time since I have had the unpleasant task of placing on the Confidential List, a Scouter involved severally with boys. I that all - or most - of the necessary background and information meeded follows.

He has so been registered since the spring of 1971; with secondary registration as Acting Websies Leader of the Websies Den in Pack 54, Leals.

James Randolph Morrison (bern in laphaster County 10/11/51) first was registered as o now Wonderfoot Scout in Wroop 2, appropriatly the Faradian Poter, Chil, Faradian, Fa. on 10/11/63. His oldress was Pird In Hand, Fa.

In 1966 he transferred to Troop 5', sponsored by the Pateville-Leola-Leonock Lions Club. His home address was - and remains the same to this late - 5' legging Road, Leola, Pa. 17540. He became on Engle Senat in this Troop on 2/10/69. He has been the Acting Growtmastor of Troop 26 wings Septomber, after the Green S.T. transferred out of the community, and see only replaced officially this peak meets.

Randy is 6' tall, wears glasses, is of slender build weighing approximately 165 lbs. He has brownish-blonde beir, brownish eyes, and by nature is nervous, easily eveitable, and quite high strung. During a recent compout (semetime during the fall of 1971) I was told it was my turn to sleep with Randy. The kids all laughed, and I felt funny, but wasn't quite sure why. After I got asleep I woke up and his hard was playing with my privates. I was scared and could hardly believe it. I never knew a man would do a thing like that. I puched his hand away when mine started to get hart. I tried to go to cleep and he did il again. When it started to big'dis and got ham I got secred again and pushed his hand away and told him to stop! We did it once more. And Mr. Teimier, I don't ever want to sloop with a man like that again!

After some further questioning it was obvious that the did not know what it was all about. He did not even know the term menturbation. I assured him that his father would be the best one to confide in, and teach him all about ser. We shook hands and that was it.

On Tuesday evening, approximately 7:30, January to, I traveled out to the Manhoim Township Middle School in Neffsville, where the Troop meets, and apoke to the following two , Langagter 17601, and Scouts in Troop 96. I was sure he was only teasing, to get me riled up.

continued. Sometime that night I felt Boody's hard on my pehis. We always had to sleep in our undershorts for Bandy - he always indisted on it. I just laid there, and he kept playing with it till it started to get hard; and when it become erected I pushed his hand away. He laughed - a weird sort of laugh, gave me the shivvers, really! I mipped my sleeping bag up and tried to go to cleep. Then I knew what my friend meant about Randy playing with a boy's penis. Once more that night I wake up and again his hand was going up and down on my penis, and I told him to stop, and I pushed his hand easy as hard as I could. I didn't want him to feel my erection. I sipped my bag back up, and slept on my stomach the rost of the night. He didn't bether me anymers.

The next night I thought, no way will I sleep in my underpants! I sleep with my clothes on, and he knew why! And I stayed mostly on my stomach so he couldn't get to my penis again. As far as I know, he didn't try that night.

I had to sleep with him again on the next compost and when he did the same thing all over again I told him off - said I didn't like that kind of stuff. Stop! He never slept with me anymore. What I can't understand is - why? We offer took me up flying in his plane, particularly to study store at night; he was constantly inviting me to go flying with him.
