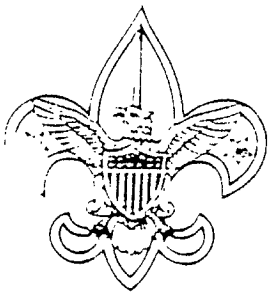

FINDINGS & JUDGMENT

There being a finding/verdict of [ ] NOT GUILTY. Defendant is discharged. [X] GUILTY. Defendant has been convicted as charged of the offense(s) of activity relating to material involving the sexual exploitation of minors, in violation of 18 USC 2252(a)(2), as charged in the information.

SENTENCE OR PROBATION ORDER

The court asked whether defendant had anything to say why judgment should not be pronounced. Because defendant was shown to have committed the offense(s) charged and convicted and because the defendant has committed the offense(s) charged, the court hereby commits to the custody of the Attorney General for his authority to represent in the institution for a period of five (5) years and on condition the defendant be confined in a jail type institution for a period of 120 days, the execution of the remainder of the sentence of imprisonment is suspended and the defendant placed on probation for a period of five (5) years-, to commence upon release from physical custody, upon the conditions of probation as contained in P.O. Form No. 7 and the following special conditions:

SPECIAL CONDITIONS OF PROBATION

- 1. Defendant shall participate in an alcohol treatment program, which may include antabuse, as directed by the probation officer.
2. Defendant shall participate in a program of psychotherapy and or sex abuse counseling, as directed by the probation officer. The treatment program may include use of penile plethysmograph, aversive condition and polygraph testing, as deemed necessary by the treatment program.
3. Defendant shall not possess any pornographic material of any kind.

ADDITIONAL CONDITIONS OF PROBATION

In addition to the special conditions of probation imposed above, it is hereby ordered that the general conditions of probation set out on the reverse side of this judgment be imposed. The Court may change the conditions of probation, reduce or extend the period of probation, and at any time during the probation period or within a maximum probation period of five years permitted by law, may issue a warrant and revoke probation for a violation occurring during the probation period.

COMMITMENT RECOMMENDATION

The court orders commitment to the custody of the Attorney General for his authority to represent in the institution for a period of five (5) years and on condition the defendant be confined in a jail type institution for a period of 120 days, the execution of the remainder of the sentence of imprisonment is suspended and the defendant placed on probation for a period of five (5) years-, to commence upon release from physical custody, upon the conditions of probation as contained in P.O. Form No. 7 and the following special conditions:

It is ordered that the Clerk of the Court file a certified copy of this judgment and commitment to the U.S. Marshal or other qualified officer.

1 4. Defendant shall refrain from association with minor children, below eighteen  
years of age, without the probation officer's approval.

2 5. Defendant is prohibited from maintaining a separate mailing facility from  
his home.


3 6. Defendant shall not frequent pornographic video arcades, massage parlors,  
4 or any other business engaged in the sale or promotion of pornographic materials.

5 7. Defendant is prohibited from association or visitation of areas where children  
congregate, such as parks and playgrounds, without the approval of the probation  
officer.

6 IT IS ORDERED the defendant pay a \$50.00 fee assessment to the United States  
7 Attorney.

8 IT IS FURTHER ORDERED the defendant voluntarily surrender to institution  
designated on or before 4:00pm, December 28, 1987 and be eligible for work release.
