

Scout Executive Statement of Suspension Letter Delivery


On Wednesday, September 9, 1987, 10.05 a.m., I conducted a conference, in my office, with Mr. James T. Davis, Jr. Present as a witness was Mr. Carlton Crump, District Executive, Winston-Salem, NC.

I delivered the original of the attached letter and asked Mr. Davis to read it. He read the letter and without emotion stated that he understood its contents and accepted the decision. I then stated his options for review of this decision based on his written request for a review. He asked that if he desired a review at a later time would it be granted. I stated that a review could be conducted at any time that a written request was granted. I also explained that this suspension of registration applied to any registered position, at any geographic location, with the B.S.A.

Mr. Davis then left my office with the original copy of the letter in his possession.


Dear Mr. Davis:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

[redacted] has accused his Scout Master James C. Davis of sexually molesting him on 2 different occasions by fondling him in his private area.

These incidents occurred in the home of Mr. Davis. Mr. Davis had told [redacted] parents that a group of boys would be meeting at his home to discuss merit badges. [redacted] told his Grandmother when he was brought back home by Mr. Davis that he was the only boy there and he didn't want to go. Unless other boys would be there but didn't tell of incidents at that time.

Today September 5, 1987 Mr. Davis called [redacted] grandmother to see if he could pick [redacted] up today to help him work for a merit badge. When his grandmother asked [redacted] if he wanted to go he refused to go unless they were sure other boys would be there. After extensive probing from his mom + grandmother he told them about the incidents that had occurred when Mr. Davis had him alone.

Mr. Carlton Crump was immediately notified. Mr. Crump asked for a written statement from the [redacted] because he had already begun to request for more information on Mr. Davis because of incidents he'd noticed that were not given about Mr. Davis from his minister who'd selected him for the Boy Scout [redacted] nomination.

Sept. 9, 1987

Mr. Davis picked me up on a Friday night from my grand mother's house to carry me and another boy [REDACTED] to his house to spend the night so he could carry us to Camp Robert Vaughn that Saturday morning.

Mr. Davis carried us straight to his house & told him I'd not showered at my grand mother's and he said I could do it at his house. After showering I put on my pajamas and the 3 of us looked at a movie on the VCR "Stand By Me".

[REDACTED] in his room on his bed. I was laying in the middle. Mr. Davis [REDACTED] to tickle me on my stomach and tickling [REDACTED] also.

When we got sleepy we went to his son's room and went to bed. He came in and woke me up later on to talk with me about my dues he said me to come in his room and tell him about the dues I'd payed. Then the other boy [REDACTED]

He got in his room and I was standing beside the dresser he was sitting on the bed dressed in a pair of shorts no [REDACTED]

up on some dues. I asked if I could get my slacks out of his closet he said

you then asked if I wanted to see another movie, I called [redacted] to come in and Mr. Davis told him to stay in the room.

I sat at the head of the bed with the covers over me looking at the movie Nightmare on Elm St. II. Mr. Davis got in his and layed down looking at me then he stuck his hand under the cover and started to fondle my penis while looking at TV for a few minutes. I moved my body in a position where he couldn't touch me then I told him I was going to the other room to go to bed. He said OK.

The next morning we went to camp and he didn't say anything or try anything on himself. That afternoon he came, we did my work and I was too embarrassed to tell what happened.

The second time happened when mid came back from the Y. I went home with Mr. Davis under the assumption that 3 other boys would be there to talk about citizenship.

When we got to his house he gave me a 7up drink we went in his study and talked about citizenship but no other boys showed up. After we finished he asked me if I wanted to go home or look at a movie since no one was at my Grandma's house. I said look at a movie.

We went in his room and I layed

down on my stomach on the bed
the house was hot and he told me
I could take off my shirt but, I
only pulled it over my head he looked
at my back and said it needed some
lotion on my back. He started lotioning
my back then pulled my pants down
near my knees and started lotioning my
buttocks and pulling my cheeks apart.
I looked back at him kicked my feet
on the bed and got up and pulled my
pants up. Mr. Davis asked me if I
was ready to go home and I said yes.
He carried me to the service station
with out mentioning anything about
what he'd done.

I didn't tell my my parents about
it until last Saturday when he wanted
them to let me come over to his house
to work on meints.
