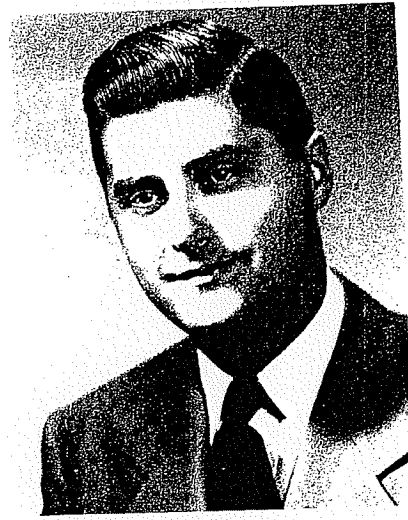

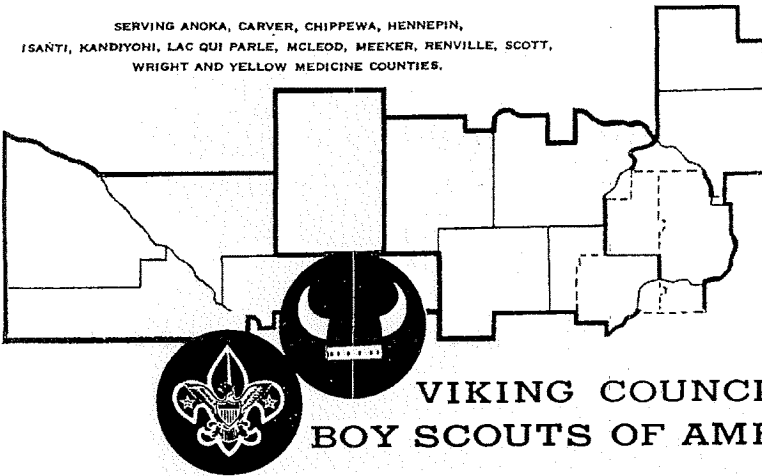

Dear Boy:

For sometime I have been attempting to follow up on my previous notification of the resignation of James Bartlett from our staff. However immediately after the incidents were disclosed he left for the West Coast and then, I understand, Hawaii. I do want to put in writing the facts so you may have them in your file.

Jim was a local product having come up through Scouting as a boy, serving on the Camp staff as a Counselor-in-Training and came up through all the Camp jobs. Entered professional scouting and continued to serve in Camp during the summer - being in charge of interviewing and hiring the staff - with special emphasis on the younger group, referred to as "Counselor-in-Training".

On August 8 I visited the Camp and became suspicious of the intentions and interest of this man. I heard numerous references to him as "the queer" - this

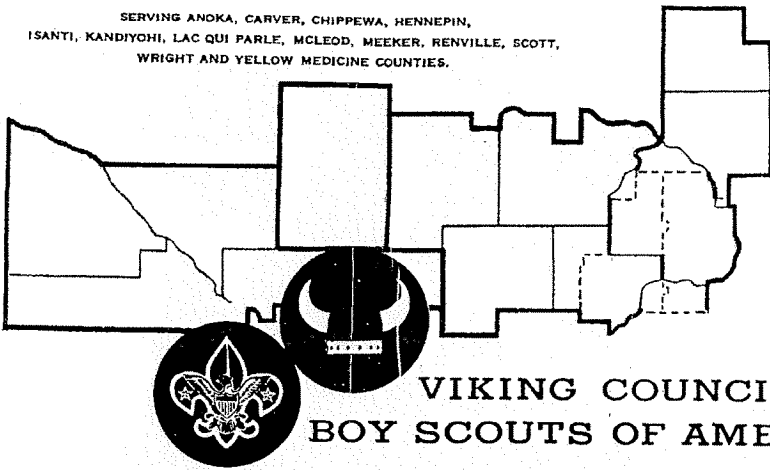

[redacted] father is a District Commissioner whom I knew. At a luncheon discussion we disclosed our suspicions and suggested that since his son had been at camp for several years perhaps he could give us any facts about which he knew - or at least tell us if he had heard any stories about Bartlett. Mr. [redacted] a good friend of Bartlett's said he knew the stories were unfounded, but would talk to his son. The next day he called, saying "My son knows all the facts because he has been involved for several years but was afraid to talk because he didn't want to lose his job." He then proceeded to tell what happened - certainly it was more than a "back massage" -

The next morning in the presence of Robert Wellhaus, I talked with Jim in my office, stating I had talked to a number of parents, Scouts, and legal authorities and had many, many facts about incidents at camp - I mentioned that if it were necessary I would bring all these people in to face him with the facts. He immediately admitted that since he was 16 or 17 he had these homosexual tendencies and that he did
