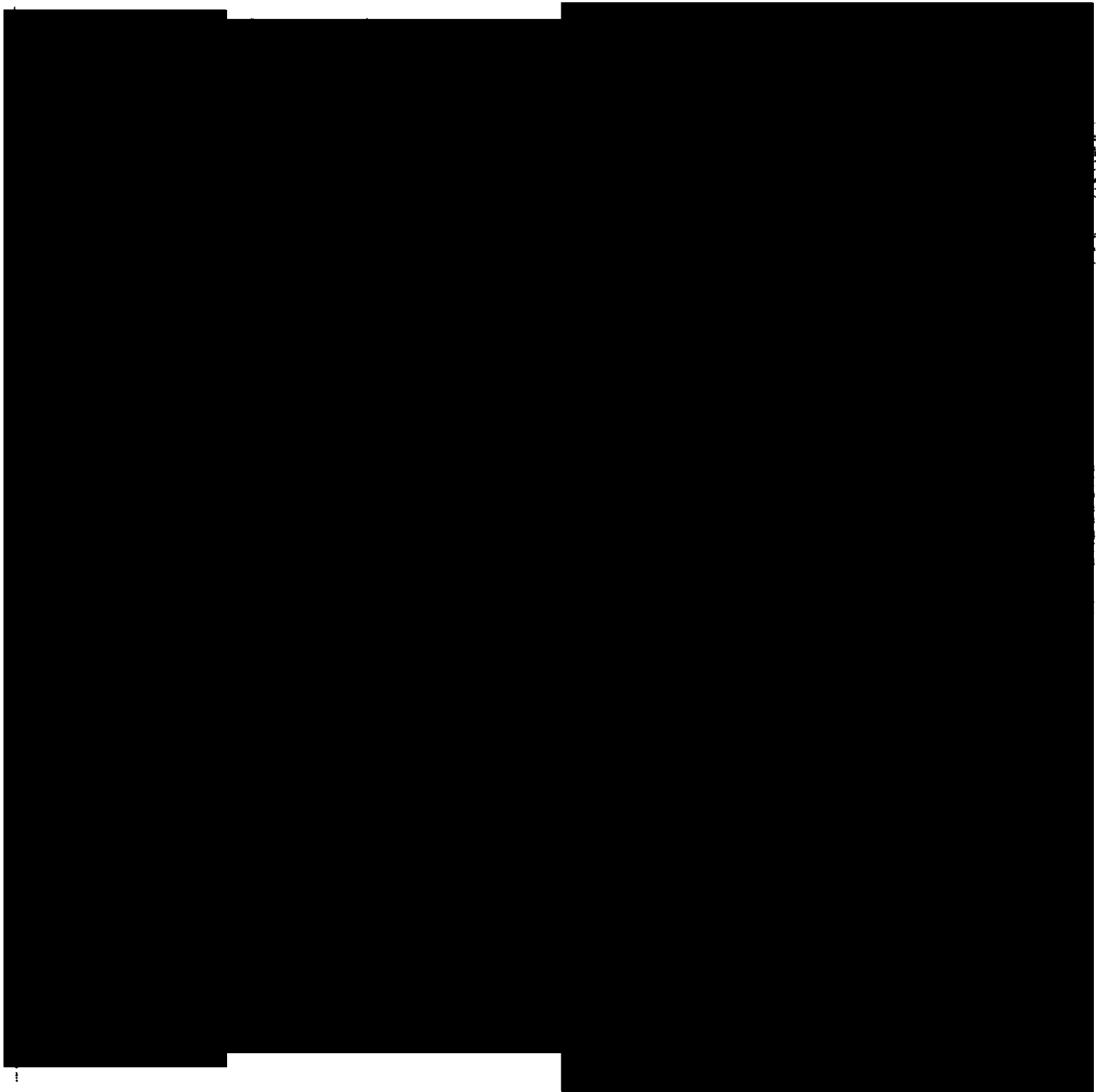

VICTIM SERVICES STAFF KAREN KNOX WAS REQUESTED BY SGT. BOYDSTON TO CONDUCT A VIDEOTAPE INTERVIEW WITH [REDACTED] WHO IS 11 YEARS OF AGE. HE IS IN THE 5TH GRADE AT [REDACTED] ELEMENTARY SCHOOL. I QUALIFIED HIM AS TO KNOWING THE DIFFERENCE BETWEEN THE TRUTH AND A LIE, AND HE TOLD ME THAT EVERYTHING THAT WE WOULD BE TALKING ABOUT WOULD BE THE TRUTH. HE IDENTIFIED THE BODY PARTS AS FOLLOWS ON THE A/C DOLLS-GREASE-TITTS, PENIS-PRIVATE, BUTTOCKS-BUTT. HE TOLD ME THAT JAMES JACKSON SUCKS ON HIS DICK. HE SAID THAT JAMES USED TO LIVE IN THE [REDACTED] APARTMENTS WHERE [REDACTED] LIVES. [REDACTED] SAID THAT JAMES DID THIS TO HIM AT JAMES' APARTMENT. I know sometimes that cases can drag on a long time, but if this case has been completed then we would have a file which would enable us to refuse registration anywhere in the country.

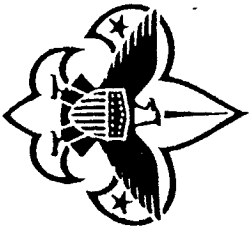

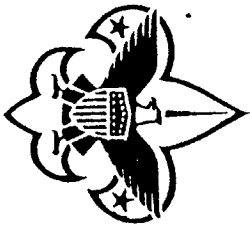


