On December 13, 1978 Ken James was in our home in preparation for a District Commission training session. Ken's uniform was at the dry cleaners and he left the house to pick it up. On leaving, Ken invited my oldest son [redacted] to go with him. [redacted] accepted and went to the dry cleaners to pick up the uniform. After leaving the cleaners and on the way back to our house, Ken told [redacted] that he would make [redacted] "very tickled" by using his theory that if you are tickled enough, you will eventually overcome the laughing. On talking back this, Ken reached across the car and began tickling [redacted] in the groin area. [redacted] told him to quit but Ken did not stop at that time, but did quit shortly. There were no further advances.

[redacted] did not tell us of the incident, nor did we have any knowledge of it until the report of gay came up at the dinner table on the evening of Feb. 8, 1979.

The foregoing tickling incident was preceded  
by her tickling [redacted] on the ribs and  
stomach while in our arms. This tickling  
by her lasted so long that it came to be  
boring and almost became cruel. Since  
[redacted] was asleep in our home and

said to her about the excessive tickling.
