The following is a statement given to G. Earl Burum on July 1, 1976 by [REDACTED], father of [REDACTED], about an incident involving James W. Reed, former Scoutmaster of Troop 40, Eagle District, Our Lady of Perpetual Help Catholic Church.

On Wednesday, June 9, 1976, James W. Reed was staying at his sisters and asked [REDACTED] to mow her yard. Since they thought it would be late, Reed asked [REDACTED] could spend the night and return home early on Thursday morning, June 10, 1976.

[REDACTED] mowed the yard, ate supper about dark and visited and watched TV with Reed.

Upon going to bed, James W. Reed approached [REDACTED] allow Reed to commit an act of Sodomy. [REDACTED] refused and Reed backed off and [REDACTED] stayed awake all night because he was afraid to go to sleep.

The next morning Reed paid [REDACTED] by check for mowing the lawn and gave him all the cash he had (about \$7.00) and asked [REDACTED] not to say anything to anyone about the incident the night before. [REDACTED] laid the money down on the seat of the car and left.

About 1 and 1/2 hours after [REDACTED], returned from work (4:00 or 4:30) [REDACTED] told his father he did not want to go to Scout Night with the [REDACTED] and [REDACTED] younger brother [REDACTED] also said he did not want to go. [REDACTED] asked why and [REDACTED] related the above incident.

Around 5:00 P.M. on June 10, 1976, [REDACTED] talked to [REDACTED] another Scouter in Troop 40.

Shortly after 6:00 P.M. on June 10, 1976, James W. Reed arrived at the [REDACTED] home to take the boys to the ball game.

[REDACTED] and [REDACTED] met Reed on the front porch and [REDACTED] told Mr. Reed that in view of last night's incident, he should resign. [REDACTED] agreed and Mr. Reed indicated he would resign. Mr. Reed did not deny in any way this incident and no-one from the Troop went to the ball game. Mr. Reed resigned on June 11, 1976, by letter to Mr. Keith Foster, Troop 40 Committee Chairman.

On June 17, 1976 Mr. [REDACTED] was registered as Scoutmaster of Troop 40.

This report is as [REDACTED] gave his view of the incident to me.

I agree that this report is as I gave it to Mr. Burum.
