Please delete Mr. Spangenburg's name from your records.

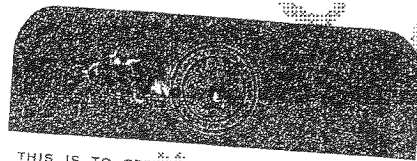
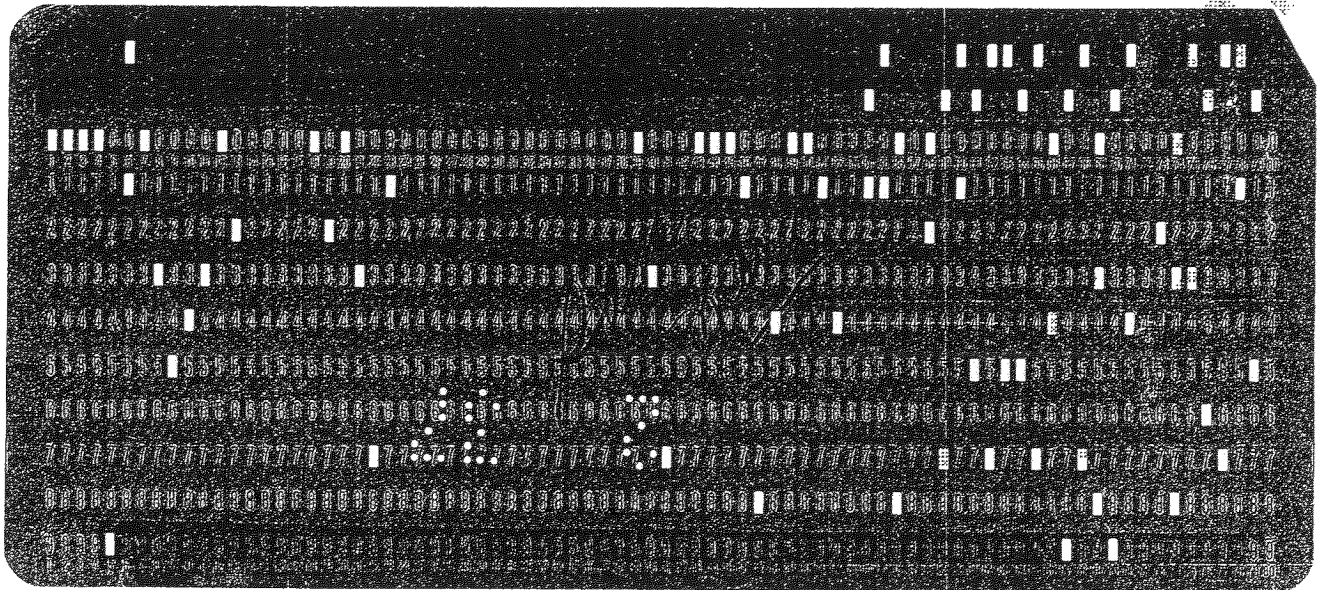

## Valley Man Is Held in Morals Case

A 22-year-old Conyngham man charged by the state police with three separate morals offenses involving six Conyngham boys posted \$3,000 bail on the three charges after he waived hearing before Alderman Thomas Domin. State police disclosed yesterday.

The accused, identified by police as Jay George Spangenburg, 389 Main Street, Conyngham, was arrested on September 10 and was given a hearing that same day before Alderman Domin.

State police reports show that after the hearing was waived, \$2,000 bail was posted on a sodomy charge and \$500 on each of the other two charges: corrupting the morals of minors and indecent assault.

State Trooper Richard Sachs, who was assisted in the case by Conyngham Chief of Police Robert Thomas, reported that the offenses with the young boys were reportedly going on for approximately one year.

Trooper Sachs said a further investigation is under way.
