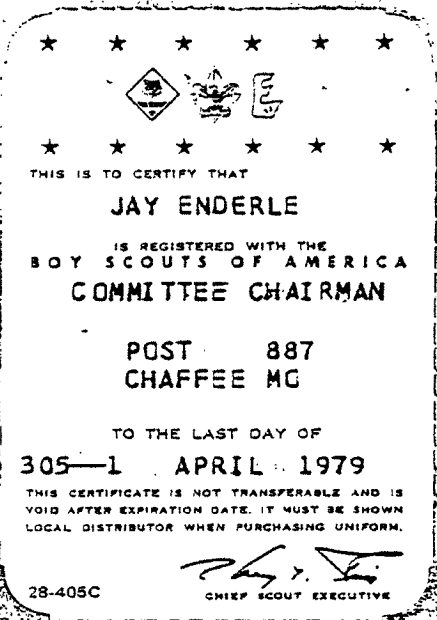

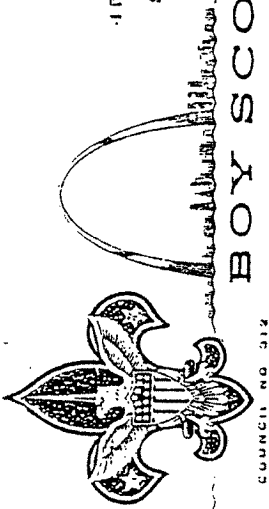



Dear Mr. Beckner:

I am very sorry I have to write this letter, but for the good of scouting, I feel I must.

Mr. J A (Jay) Enderle , a 24 year old single man, who is registered with our troop ( 250 of Perryville) as an assistant scoutmaster, has engaged in Homosexual acts with some of our scouts. Several of our scouts have told me of this, So I have personal knowledge of this.

The boys who have told me of his homosexual acts with them are good responsible young men, I have questioned them several times on this , and I can see no reason why they would lie.

Mr. Enderle has moved from Perryville now, so we don't have the problem anymore. But I think it is my duty to notify the scout office so other scouts in the future will not have this problem. Maybe Mr. Enderle is getting help for his problem and sometime in the future he may be a good scout leader, but I think if he works with youth , either in scouting or some other group, the adult in charge should be told of the problem we had with him in Perryville in 1973.

I think Scouting is a good thing for the boys, and I have tried to do my part, so I would hate to see it get a bad name , because of a few odd balls.

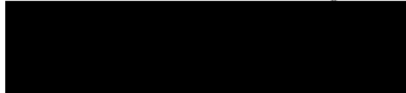
