Escent charges have been made by eight (8) boys have in the Home of your fondling them at various times here on this grounds. In regards to the character of the children who are involved, the reported tactics which were used by you to seducing them cannot be excused.

It was reported that threats were made by you to the boys of bringing a boy to the office for engaging in homogenical acts among themselves. Instead of actually bringing a boy to the office to answer to the accused offense, he would be carried to his individual room or a bathroom and subjected to abnormal demonstrations in your presence. Identical charges were made by most of the boys involved. If you found any boy involved in homosexual practices it was your duty to report any immoral acts to the office. Your failure to do so is a serious mistake. The boys involved cannot be excused for their part in these practices nor the act condoned; as an adult your responsibility is greater. The act is regrettable and unfortunate.

In view of the circumstances, you are kindly requested to submit your letter of resignation effective December 9, 1960, and of work day. Hesignation will be effective December 16, 1960.

May God help you in future adjustment.




