Sentences total 72 years in Scouts' assault case

LIVE OAK — A former Branford councilman, church deacon and Boy Scout leader has been sentenced to a total of 72 years in prison by two North Florida judges for sexually molesting boys in the Scout troop he led.

Jesse James "Jamie" Slocum Jr., 45, was silent yesterday when Circuit Judge Wallace Jopling added 22 years to the 50-year sentence Slocum received Monday in Gilchrist County on similar charges.

Jopling told Slocum that he was recognized as a leader, but he had disgraced and damaged his family, himself, the Boy Scouts, his community and his church.

"I can see people holding opinions against religion and Scouting because of what you have done," Jopling said.

Jopling stayed within Florida's sentencing guidelines, which recommend a total of 17 to 22 years for the four sexual batteries and six

counts of a lewd act against a child. Slocum pleaded guilty to the charges in Suwannee County in September.

Circuit Judge Stephan Mickle of Gilchrist County went outside the guidelines Monday when he gave Slocum 50 years for sexually assaulting two Scouts on a troop camping trip on the Suwannee River near Bell in March.

The guidelines recommended a 12- to 17-year sentence for the Gilchrist County charges of three counts of sexual battery and three counts of a lewd act against a child.

The sentences in both counties were made consecutive.

"When a big tree falls it crushes the little trees around it. Your conduct not only crushed a tree, it has shaken the foundation," Mickle told Slocum.

Slocum was arrested after the March camp-out when the two Scouts told their parents he had

raped them in his tent. The parents informed authorities who began a two-county investigation.

"It was during the investigation that three more victims came forward with information they had been assaulted in Suwannee County.

Assistant State Attorney John Terhune said yesterday he was pleased with the sentencing in the two counties.

"He will be at least 81 before he will be eligible for parole," Terhune said.

Slocum's attorney, Huntley Johnson of Gainesville, said he intended

to appeal the sentencing in Gilchrist County. Johnson said Mickle's reasons for going outside the guidelines were not sufficient for the severity of the sentences.

Mickle said his sentence was stiffer because Slocum premeditated and planned the sexual abuse of the boys in his charge for over 20 years, using pornographic magazines to introduce them to the idea.

Johnson said going outside the guidelines because pornography was used in child molesting cases had never happened in Florida before. It will be the first time an appeal has been based on it, Johnson said.

"The saddest part of this whole

case is that, in my opinion, Jamie Slocum could not help himself," Johnson said. "Like an alcoholic and liquor, Jamie had an uncontrollable urge for young boys and couldn't stop."

Terhune said adults came forward to testify that Slocum had sexually molested them when they were in his scout troop. One reported molestation occurred in 1966.

Terhune said that investigators found magazines such as Harvey, Hustler and the Visual Dictionary of Sex in the Boy Scout Hut where Slocum held his scout meetings in Branford.

Branford is a town of about 850 south of Live Oak on the Suwannee

River.

Slocum, the father of two, had been Scoutmaster of Troop 90 at Branford the past 25 years. The troop was disbanded after he was arrested. Community leaders are now trying to organize another troop.

Slocum said in an interview with a psychiatrist that his stepfather raped him when he was 8 and 9 years old.

The psychiatrist's report on file with the court said Slocum appeared to have a stable marriage, but he admitted raping his first Scout when he was 28 years old.

LIVE OAK — Additional charges of sexual battery and lewd acts upon children have been filed against a former Boy Scout leader who also served as a city councilman and church deacon.

Assistant State Attorney John Terhune said molestations dating back to 1966 have been revealed in the case against Jessie James "Jamie" Slocum Jr. He was accused Thursday of sex acts with members of Branford Boy Scout Troop 90 in Suwannee and Collier counties, Terhune said.

The facts:

Jessie James Slocum, Jr., Live Oak, Florida (North Florida Council, Jacksonville), is charged with various "sex acts" involving members of Branford, Fla. Troop 90, Live Oak. Incidents are alleged to have occurred over a 20 year period. In addition to serving as a Scout leader, Slocum also is a city councilman and church deacon.

A Mr. Harvey, of the North Florida Council, confirmed the events as reported. He said the initial charges resulted from alleged sexual battery involving a 12 and a 13 year old Scout. Slocum holds the Silver Beaver and other BSA awards.

Paul Ernst provided the necessary forms several weeks ago to remove Slocum from his BSA leadership role(s). The council says they have done so, but have not reported the matter to national. "We wanted to keep it quiet and handle it at this level," said Harvey, who added he was upset that the newspapers would report matters like this.

ACTION OR RECOMMENDATIONS:

Council will talk with Ernst and Harvey said he would follow-up to see that the suspension paperwork is completed. He was advised regarding "what makes news" and how best to respond in this instance.

Austin says Greene d

It is not a crime for a prosecutor to handle a case against a friend, State Attorney Ed Austin testified yesterday, or he would have had to disqualify himself in about half the cases prosecuted by his office.

"You can't disqualify yourself because you know someone," Austin said.

"If that were true, I'd have to get an increase in my budget so the governor could send in a special prosecutor to handle about half the cases in my office," he said.

Austin testified for more than three hours yesterday as a witness for his former chief as-

stant, Ralph Greene.

Greene, who resigned in August 1983, is being tried on federal charges that from 1981 to 1983 he conspired with the late Duval County Judge Jesse Leigh to defraud the public by intervening in criminal cases involving their friends.

Greene also is charged with 10 counts of mail fraud because documents related to 12 cases, which were cited in the federal indictment, were mailed through the U.S. postal system.

Throughout the six days of the trial, defense attorneys have tried to show that although Greene may have recommended to assistants how to dispose of the 12 cases, his recommendations did not affect the outcome of any case.

Yesterday, Austin testified as a witness in previous proceedings. He had reviewed the trial and felt he would not have anything to add.

Nothing was checked into the grand jury because of the trial, Austin said. Austin, a prosecutor, has recommended a number of cases including several and FBI officials that involve the

Ex-Boy Scout leader pleads guilty in sex cases

Jessie James "Jamie" Slocum, a former Bradford town churchman, church deacon and Boy Scout leader, pleaded guilty Friday to charges that he sexually assaulted members of his troop during Scout meetings and camping trips.

Slocum had oral sex with two Boy Scouts, ages 12 and 13, in his troop during a March camping trip near Bell. He also molested a third Boy Scout on camping trips in Suwannee County and behind the troop's meeting house in Bradford.

Gilchrist County deputies arrested Jessie Slocum in March after a boy returned from a camping trip and told his mother that the scoutmaster had sexually assaulted him.

In return for the guilty plea, the prosecution dropped eight of 24 charges against Slocum, said assistant state attorney Bruce Curtin.

"He agreed to plea to everything we could prove in court," Curtin said. He added the guilty plea will relieve anxiety felt by Slocum's victims, who now won't have to testify in court.

Slocum originally faced sexual battery and lewd and lascivious assault charges in Gilchrist, Suwannee and Columbia counties. But the state agreed not to pursue two charges in Columbia County as well as six of 12 charges in Gilchrist, Curtin said. Slocum pleaded guilty to all 10 charges in Suwannee County.

"We've been in touch with the victims," said Curtin. "All of them are very satisfied with this outcome."

Gilchrist County sheriff's deputies arrested Slocum in March after a 12-year-old boy returned from a camping trip near Bell and told his mother that the scoutmaster had sexually assaulted him the previous night. Later, another troop member told the sheriff's department that Slocum had assaulted him. Slocum had molested that boy on many other occasions, Curtin said, but the boy had

Boy Scout leader gets 50 years in sex case

TRENTON - Former Boy Scout leader Jesse James Slocum was sentenced to 50 years in state prison today for molesting boys in his Bradford troop.

Circuit Judge Stephen P. Mickle went beyond Florida sentencing guidelines to give Slocum a harsher sentence for what Mickle called "a betrayal of the community, parents and most of all the young boys."

Slocum, 45, pleaded guilty in September to sexual assault charges. He was sentenced today on three counts of sexual battery against Scouts

and three counts of a lewd act upon a child. He faces sentencing tomorrow in Live Oak on 10 similar counts.

Mickle said that he realized the sentencing guidelines called for only 12 to 17 years in prison for the crimes, but the nature of the predication in the case made him feel he had a duty to go outside the guidelines.

Slocum was a state Department of Transportation engineer at the Lake City DOT office. He also was a former Bradford courtman, deacon in the local church, and won Scouting's highest award to an adult, the Silver Beaver Award, during his 25 years as a Scouting official.

The charges grew out of complaints from parents after Slocum took Troop 90 members to a

campout on the Suwannee River near Bell in March. A two-county investigation ended with Slocum's arrest.

Several families from Bradford whose sons are Scouts attended the sentencing in Trenton today. They sat in the back of the courtroom and did not come forward when Mickle asked them if they had any comments.

Assistant State Attorney John Terhune told the judge the parents had made statements about the case in letters submitted to the court.

Circuit Judge Wallace Jopling will sentence Slocum in Live Oak tomorrow for the crimes that occurred in Suwannee County.

Slocum's attorney, Huntley Johnson of Gainesville, said he would appeal today's sentence.

SENT WRITER - Former Bradford Scoutmaster Jesse James Slocum was sentenced to 50 years in prison yesterday for sexually molesting boys in the Boy Scout troop he led for 25 years.

He is to be sentenced today on 10 similar counts stemming from an incident in Suwannee County.

"You betrayed the community, the church, Boy Scouting, and most of all the young boys placed in your hands by trusting parents," said Circuit Judge Stephen P. Mickle of Gilchrist County.

Slocum, 44, pleaded guilty in September to six sex charges in Gilchrist County and to 10 counts in Suwannee County. Prosecutors built two cases because the offenses occurred in two counties.

In the Gilchrist County case, Slocum admitted he sexually assaulted two Scouts during a camping trip to the Suwannee River near Bell in March.

In the Suwannee County case, Slocum pleaded guilty to four counts of sexual battery and six counts of committing a lewd act on a child. The case, dating back to 1984, involved three Scouts.

Although sentencing guidelines suggest prison terms for the six Gilchrist offenses of 12 to 17 years total, Mickle sentenced Slocum to 10 years on each of three counts of sexual battery and 6.6 years on each of three counts of committing a lewd act on a child by a person in a custodial position. The sentences will run consecutively.

"This is the most disturbing case I have had in my seven years on the bench," Mickle said. "It was a premeditated, coldly calculated

plan and you used pornography to help you in your designs on these young boys."

Mickle said he inspected one of the pornographic magazines police found in the Bradford Scout hut. Slocum showed the magazines to troop members, prosecutors said.

"That type of garbage is not to be shown to anybody, especially boys," Mickle said.

Slocum's attorney, Huntley Johnson of Gainesville, objected to Mickle's reference to the pornographic magazines, saying the magazines did not belong to Slocum.

Johnson said he will appeal the sentence. He declined further comment until Circuit Judge Wallace M. Jopling sentences Slocum at 9 a.m. today in Live Oak.

The charges were the result of a two-count investigation that was launched after two Scouts reported to their parents they were molested by Slocum on a camping trip.

More Scouts came forward during the investigation with claims that Slocum molested them, said Assistant State Attorney John Terhune. Some adults, who were former Scouts, testified that Slocum had molested them in the 1960s, Terhune said.

Slocum said nothing at the sentencing yesterday. He chewed gum throughout the proceedings and never looked out into the audience, where two Scouts with their families sat on the back row.

Mickle invited the Scouts' family members to speak at the sentencing, but no one came forward. Troop members and their families had presented written statements to the court, Terhune said.

Slocum was a town councilman at the time of his arrest in March. He resigned the post

after his arrest. He was employed as an encroacher with the state Department of Transportation office in Lake City when he was arrested.

Previously, he served as a deacon in the First Baptist Church of Bradford. Slocum had received the Silver Beaver Award - the highest award an adult can receive - for his more than 20 years of service. Last week, the North Florida Council

Boy Scouts voted in Orange Park to revoke the award because Slocum falsified the information it was based upon.

"It is the first time in the history of Boy Scouting in Florida that such a thing has happened," said Steve Moore, director of supply services for the Jacksonville-based council.

Slocum told court-appointed psychiatrist George W. Barnard in an interview that Slocum's stepfather abused him sexually when he was a child, according to Barnard's writ-

ten report to the court. Slocum's mother was divorced when he was eight and remarried when he was nine, Barnard said.

Barnard described Slocum as a child molester who needed further therapy. Slocum has average intelligence and understood what was a stake in the sentencing process, Barnard said.

Barnard's report gave no guarantees that Slocum had mastered his psychological problems. Terhune said

Asbestos concern closes NAS laundry

One week after Jacksonville Naval Air Station officials said concerns about asbestos in the workplace had been laid to rest, the base laundry was closed yesterday for a week while faulty asbestos pipe insulation was repaired.

Navy and city health inspectors, alerted by complaints from civilian employees, said recently they found no areas exceeding asbestos air standards in random samplings at the base.

Then, earlier this week, the employees complained again that the fiber material was exposed through loose pipe insulation at the laundry, where several dozen workers spend eight hours a

day and where hundreds of customers stop by.

"There were pieces of loose asbestos lagging [wrapping] all over the place, hanging down to within two feet of where people are working at the steam presses," said plumber Danny Allen, a member of the base's public works department for the last eight years.

Asbestos is a fibrous mineral that has been used widely for insulation. When airborne, it can be inhaled and cause lung cancer and other respiratory ailments. Experts estimate that between 100,000 and 300,000 people worldwide will die by the end of the century from asbestos-related illnesses.

More than 30,000 asbestos-related damage law-

suits are pending before state and federal courts across the country. In Duval County, about 150 suits have been filed.

"We've been finding it [asbestos] all over the base as we've been sent out on jobs repairing pipes," Allen said. "Public works employees are not supposed to be working with asbestos but we are, every day."

He and Ron Williamson, the base occupational safety and health manager, said yesterday they have found loose asbestos throughout the base — in air-conditioning ducts and heater pits at the naval telecommunications building, the naval supply

Branford official charged with sexual assault of Boy Scouts

BRANFORD — A Branford constabulary and Boy Scout leader has been charged with sexually assaulting two members of his troop during a weekend campout.

The arrest of Jesse James "Janle" Slocum Jr., a church and civic leader, has stunned residents of his small North Florida town.

"The whole community is in a state of confusion, not knowing what is going on," said the Rev. Kermit Matthew, pastor of Slocum's

church in Branford.

Slocum, 44, was being held in the Gilchrist County Jail on \$100,000 bond last night.

He was arrested at his home in Branford on Monday after a 12-year-old troop member told his parents that Slocum sexually assaulted him when they shared a van Friday at a campout at Log Landing, west of Bell on the Suwannee River in Gilchrist County.

The parents took the boy to a hospital for treatment and notified Suwannee County deputies.

Then, a 13-year-old member of the Scout troop told Gilchrist County investigators that he had been assaulted by Slocum on Saturday night.

The boy said it wasn't the first time Slocum had assaulted him, but that he was too frightened to report the earlier incidents, police said. Gilchrist and Suwannee county officials are interviewing parents and troop members during a joint investigation to determine whether more charges should be filed, said Doug Beach, sheriff's investigator in Gilchrist County.

Suwannee County Deputy James Tucker, who is regularly assigned to Branford, is conducting the investigation in the small town on the Suwannee River, 25 miles south of Live Oak. Slocum, a lifelong resident of Branford, has been a Scout leader for 24 years. In January, he was awarded the Silver Beaver award, the highest Scouting honor given to adults.

Troop 89, which Slocum supervises, always has been an award winner, said Gerald Riehl.

well, Scout program chairman for the Manatee District.

Stocum has been on the Branford Town Council for 10 years. He works for the state Department of Transportation at its district office in Lake City.

He is a Sunday school teacher and

deacon in the First Baptist Church of Branford. He is married and has two children.

Branford was stunned by the news of Stocum's arrest, Mayor Gene Broome said.

"He is well thought of here. We are all shocked," Broome said.

Should Stocum be indicted by a

grand jury, Gov. Bob Graham would be responsible for suspending him from public office, Broome said.

The governor can suspend an elected official who is charged with a felony even before he is indicted by a grand jury "but it is rare," said Greg Smith, an assistant legal counsel in Graham's office.

Smith said Graham apparently had

not yet been informed about the case or asked to take action.

Stocum maintains he is innocent, said his attorney, Humley Johnson.

"I've known Jamie and the family for years," Johnson said. "I've very hard to believe any of it."

Johnson said he would request a bond-reduction hearing next week.

NAS laundry closes for repair of asbestos pipe insulation

center, the base administration building and other areas.

As instances of loose asbestos in the workplace are reported, the Navy tries to at least temporarily resolve the problem, Navy spokesman Nick Young said.

The work being done through the next several days at the laundry includes re-taping and encapsulating the pipe insulation that has deteriorated, he said.

"We are as concerned about killing

people with asbestos as anyone else in the city," Young said.

"We're like most industries — years ago, we were building buildings using asbestos for insulation, and we were starting a problem we didn't know about."

"Even in 1967, when Hangar 1000 [an aircraft hanger at Jacksonville NAS] was built, they used asbestos lagging around the pipes. And it's in most of the ships. They have heating pipes going right past the bunks aboard that the guys used to dig at with knives.

"But because of the sheer magnitude of the project, we can't just remove all the asbestos from every Navy structure — that would be in the billions of dollars. We're going to have to resolve this as the budget permits."

Young said that while the Navy has no programs to make itself asbestos-free, neither does the city.

Indeed, Lee Fegan, an air toxics inspector for the city Biological/Environmental Services Division, said yesterday that Jacksonville follows federal regulations on asbestos

matters.

The U.S. Environmental Protection Agency requires that it be notified before buildings with certain amounts of asbestos can be renovated or demolished. And the Occupational Safety and Health Administration says that a worker's breathing zone must not exceed two fibers per eight-hour workday.

The EPA and the base's safety and health department have taken air and soil asbestos tests recently at Jacksonville NAS, and all of the results met safety standards.

Slocum was arrested after lawmen were told by the victims' parents that Slocum raped them in March during a camping trip at Log Landing in Gilchrist County.

The victims said they were raped by Slocum after he spent the night with them in their tents.

In an interview with psychiatrist George Barnard of Gainesville, Slocum, said he too was a victim of child abuse. Slocum said his stepfather raped him for two years -- from ages 9 to 11, court records show.

When assaulting the victim, Barnard wrote, Slocum's memory went back to what his stepfather did to him.

Barnard also wrote that while Slocum appeared to have a "stable" marriage, he had admitted raping his first scout when he was 25 years old.

In sentencing Slocum, Mickie pointed out that Slocum used pornographic materials as a means of arousing the sexual urges and curiosities of boys.

In the Branford Boy Scout hut, investigators found pornographic magazines "Harvey," "Hedeker," and the "Visual Dictionary of Sex."

"I'm pleased with the sentencing," Assistant State Attorney John Terhune said today. "The guidelines recommended a maximum of 39

(year in prison...), and he ended up with a total of 72 (years). He will be at least 81 years old when he walks out of the state prison."

Neither Slocum nor his lawyers were available for comment.

While the courts worked to close the book on the Slocum case, Mickie said the victims are still haunted by the incident.

"When he bothered me the first time I really didn't understand and I didn't know what to do," one victim said in a letter to the judge. "I was scared."

"I feel like the other kids are talking about me behind my back."

That one victim's letter and letters from others, including the victims' parents, were taken into consideration in rendering the sentence, the judge said.

"We had no idea that he was stalking and grooming (my son) as his next victim," one parent wrote to the judge. "I can't tell you how many times I told (my son) to do as James told him."

Slocum, the father of two and Scoutmaster for Troop 90 for 28 consecutive years, was a respected member of the Branford community. He was a deacon and Sunday school teacher at Branford Baptist Church. Troop 90's headquarters were located at the church.

Since the incident, Slocum has resigned from his post as a Branford town commissioner and is no longer a member of Branford Baptist Church. Boy Scout Troop 90 has disbanded. Scouts leaders are trying to restart the unit.

After the sentencing Monday, Slocum's former pastor, the Rev. R. L. Matthews, said the crimes were unforgivable by the ex-scout leader have "shocked" the residents of Branford. And he believes the mistrust and worries by parent will be lasting -- at least for awhile.

"You just don't think this kind of thing can happen," said Matthews. "The waves are not over yet and I don't know when they will be."

Branford Mayor Gene Broome said he will be glad when the incident is behind the town.

"It has affected the town's people and the community has been devastated," said Broome. "We are pleased that maybe we will be able to put this thing behind us."

Slocum, who was stripped of his Silver Beaver Award, the highest honor an adult can receive in scouting, also faced charges in Columbia County, but they were dropped as part of a plea bargain agreement with the state.

Ex-Scout leader pleads guilty

Former Branford Boy Scout leader, church deacon and town councilman Jessie James "Jamie" Slocum pleaded guilty in Lake City

to 16 counts of sexual assault of members of his troop while at Scout meetings and on camping trips.

According to Assistant State Attorney Buck Curtin of Gilchrist County, Slocum pleaded guilty to three counts of sexual battery by a person in custodial authority and three counts of lewd acts on a child in Gilchrist County.

He pleaded guilty to four counts of sexual battery by a person in custodial authority and six counts of lewd acts on a child in Suwannee County.

Curtin said the prosecution dropped 24 charges against Slocum, including two in Columbia County, in return for a guilty plea.

"By Slocum pleading guilty, this will relieve anxiety felt by his victims, who now will not have to appear in court," Curtin said.

"However, each victim will be given the opportunity to address the court and give their comments on how they feel before sentencing is

passed," he added. Slocum's sentencing is to be scheduled sometime November, according to Curtin.

Slocum was first arrested in March in Gilchrist County by sheriff's deputies after a 12-year-old returned from a Scout camping trip near Bell told his mother Slocum had molested him during the previous night.

Later, a second scout told authorities he too had been assaulted by Slocum. After that, an investigation was launched by State Attorney's Office officials.

Slocum has been in Gilchrist County jail under a \$100,000 bond since his

arrest.

After the investigation began, other Scouts and former Scouts testified of Slocum assaulding them on outings.

Five Oak Assistant State Attorney John Terhune also said at least three adults who were former Scouts came forward with allegations of sexual abuse by Slocum.

According to Curtin, Slocum could be sentenced to 135 years in prison and fined \$50,000 for the crimes he committed in Gilchrist County. For the Suwannee County charges, Slocum could be sentenced to another 210 years and fined \$100,000.

been too frightened to tell anyone.

When the state attorney's office began investigating, Curtin said, other Boy Scouts came forward and told of Slocum's lewd acts behind the troop headquarters building in Branford. He also had molested children during camping trips in Suwannee County and possibly in Columbia County, Curtin said. All of the victims were boys.

The assistant state attorney said one former troop member told him he had been molested by Slocum 20 years ago. The scout leader was not charged with all of the illegal sex acts he committed, Curtin said, because Florida's statute of limitations prevents charges for crimes that happened more than four years ago.

Slocum appeared before judges in Gainesville and Lake City Friday morning. Curtin explained that Slocum had to make separate pleas to two circuit judges because he committed some crimes in the 8th Judicial Circuit and others in the 3rd.

Slocum pleaded to the Gilchrist charges at the Alachua County Courthouse in Gainesville. Circuit Judge Stephan Mickle set sentencing for Nov. 3.

After that hearing, Slocum was taken to the Columbia County Courthouse in Lake City. There, he pleaded guilty to the 10 Suwannee charges. Circuit Judge Wallace M. Jopling set sentencing for Nov. 13.

In the meantime, Slocum will be interviewed by a state-appointed and a private psychiatrist, said Slocum's attorney, Huntley Johnson of Gainesville.

Johnson said the consultations will be a part of Slocum's pre-sentence investigation. "If there's a possibility that he can be helped to get over the difficulties he has

concerning interaction with children, then the judge will want to know," he said.

Slocum could be sentenced to 135 years in prison and fined \$60,000 for the crimes he committed in Gilchrist County, but state sentencing guidelines call for a 12- to 17-year prison term, Curtin said. For the Suwannee charges, Slocum could be sentenced to 210 years and fined \$100,000. Sentencing guidelines call for a prison term of 17 to 22 years, said Curtin. Slocum is 45.

"We want the sentences to run consecutively," said assistant state attorney John Terhune, who prosecutes in Suwannee County. Consecutive sentences would force Slocum to spend more time in jail than he would if his sentences were to run concurrently.

Slocum was scoutmaster of Troop 90 in Branford for 24 years. He resigned from the scout troop and Branford town council a few weeks after he was arrested.

TRENTON - Former Boy Scout leader Jessie James Slocum was sentenced to 50 years in state prison today for molesting boys in his Branford troop.

Circuit Judge Stephen P. Mickle went beyond Florida sentencing guidelines to give Slocum a harsher sentence for what Mickle called "a betrayal of the community, parents and most of all the young boys."

Slocum, 45, pleaded guilty in September to sexual assault charges. He was sentenced today on three counts of sexual battery against Scouts

and three counts of a lewd act (faces sentencing tomorrow in 1 similar counts.
