The first is Jesse Clark. As you will notice on his Ineligible Volunteer Record Sheet, he has left the area and moved to, the police think, Houston. He was never prosecuted in this case, although the investigating detective has not given up either.

I believe that he was selected by an aeronautical college in this area to take part in some type of astronaut training program. That is what would take him to Houston.

In the Brian Liebold case, this has not yet come to trial. When it does, I will notify you of the outcome.
