The enclosed court reports are in reference to Vernon J. Hawks. As you can see Hawks pleaded guilty to all charges stemming from accusations that arose on July 8, 1987 and several days following. The incidents occurred at our Camp Geiger. Hawks' registration was suspended and you had asked for the final reports as soon as they were available.

In reference to Joe T. Dwyer, according to the Gower Chief of Police, no charges were filed although an investigation was made. For this reason, no information on this case can be made available to me. I understand that Joe has now moved to Texas but no one seems to know where.

I am sorry I cannot produce any further information. I hope this has been helpful.





On January 25, 1987 I delivered the enclosed letter to Mr. Joe T. Dwyer (#019556) of Gower, Missouri. I was motivated to do this by information received from the Cubmaster of Pack C-3173 where Joe was registered as Webelos leader.

The Cubmaster told me that approximately one year ago Joe reputedly got into bed with his son's friend. The friend was spending the night at the Dwyer residence.

Mr. Dwyer was not arrested or prosecuted. The Chief of Police of Gower, Missouri did confirm that Mr. Dwyer was encouraged to seek psychiatric testing.

I am writing now to inform you of the steps we have taken and to ask you to advise me of any further steps necessary.





We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.
