out. I talked with Jones. He contacted Capt
George by radio and got permission for
me to read the file. They had statement
from three boys and a signed confession
by Joel Ray Adams. Also statement by arresting
officers Sharp and Goodnight.

Capt George would not let me have copies
of the statements because they are being present
