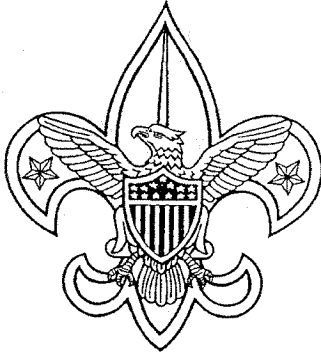
DETAILS:

At approx. 11:50 P.M. 3/29/68 these Deputies drove into the Grafton-Kennedy School parking lot and observed the above M^{ac}Lardie and [redacted] sitting in a 1967 T-Bird Lic. #819JM. Upon a closer check the adult was observed putting his pants back on.

At this time the juvenile was brought back to the cruiser where he stated that he had meet the adult at the Rest room of Frisch's. The adult then followed the juvenile to the school. The juvenile stated through questioning that they had both touched each others sexual parts and that the adult had just taken his pants down ahortly before our arrival. The juvenile stated that he has been seeing Dr. George Davidson M. S. W. A. C. S. W. for homosexual tendencies. The juvenile was then asked to go home and that we would shortly be there to contact his parents.

The adult was then placed in the cruiser and in front of Dep. R. E. Larson was advised of his rights. He then stated that he was driving down 1st street in Dayton when the juvenile pulled along side of him stated that he was troubled and wanted to talk. He was to then drive to the school where they would talk. He stated that he definately did not have his pants down and did not touch the juvenile. This is definately a lie as both of use had observed him putting pants on and the juvenile had his belt unbuckled and his fly open. The adult was then brought to the County jail and booked on investigation of Morals and Contributing.

Checking the glove compartment we found several napkins and a bottle

I am enclosing several letters and reports on a John Alfred MacLardie, now residing at 120 Devonhurst Drive, Apt. F, in Kettering, Ohio. Mr. MacLardie is currently registered as the institutional representative of Troop 233, sponsored by the Lutheran Church of Our Savior, in Kettering.

I gather because of some personal friendships with staff members, and key volunteers in the Council, this case has never been brought to the attention of the Personnel & Training Division. However, I feel that the confidential file should contain the enclosed reports and letters, and that Mr. MacLardie should be placed on the confidential list. Although the enclosed letter to Del Hanks indicates that he has resigned from all his Scouting responsibilities, he has from time to time appeared at Council events, particularly Order of the Arrow lodge meetings. He is still currently registered, although not active, in Troop 233.

We will follow your advice as to the action we should take from this point on.

ADDITIONAL DETAILS OF OFFENSE, PROGRESS OF INVESTIGATION, ETC.

At 10:45 AM this date Mr. [redacted] and his son [redacted] came in to talk with me reference this offense. [redacted] stated that he stopped by the Bus Station by the Stratford House Motel to get a pack of gum. After leaving he drove through the alley into the parking lot and the other car pulled up beside of him and spoke to him. And the subject asked where he was going, and that he told him he was going home. He then drove up on the freeway and to Neva Dr. exit and into the parking lot of the Grafton Kennedy School and the other subject drove up by him. [redacted] stated that he got out of his car and into this other subjects car, and they talked for awhile, and played with each other's penis. He said that John MacLardie had his trousers down and that [redacted] only had his open, and that the officers came up before they had a chance to do anything other than play with each other. He also stated that he had never seen this subject before.

Mr. [redacted] was very cooperative, and stated that he suspected that [redacted] had problems before and had followed him and caught him in his homosexual activities and that he is presently seeing a doctor. He also said that his son would be in court at any time and would tell the complete truth.

Att. Robert Leland was in and agreed to have Mac Lardie in when contraband charged are filed. MacLardie was released long form, I will talk with the prosecutor Monday. MacLardie only has two traffic arrests at DPD and no record with this department.

Dear Mr. Wilson:

Mr. John MacLardie was seen for psychiatric evaluation through our psychiatric team approach. We find him to have a personality disturbance associated with traumatic experiences in early childhood, particularly the death of his father in an auto accident, and the accidental death of a younger brother. He has experienced some confusion over masculine identification, especially earlier to adolescence, but has, for the most part, made an adequate adjustment. The incident which led to his recent arrest may best be understood as an impulsive, regressive act, linked with certain self-defeating aspects of his personality.

It is felt that Mr. MacLardie can benefit from psychotherapy, and he has begun treatment with one of our staff.
