Your application for probation has been received and approved by this Court. In accordance with the authority vested in Court by the laws of the State of Missouri, you are hereby placed on probation for such a period of time as required by statute; or you have proven by your conduct, to the satisfaction of this Court, that you are entitled to discharge from this probation. You are hereby advised that under the law the Court may at any time revoke or modify any conditions of the probation, and you shall be subject to an order of the Court. At any time within the period of your probation the Court may impose or order execution of sentence for the original offense in accordance with the laws of the State of Missouri, and commit you to such institution as provided by law.

It is the further order of the Court that your case be assigned to the supervision of the State Board of Probation and Parole and its representative Probation and Parole Officer. The officer is authorized to report to this Court on all matters pertaining to your probation and to make such recommendations and take such action as the Court may require in your case. You are subject to the following conditions:

CONDITIONS OF PROBATION

1. LAWS: I will obey all the federal and state laws, municipal and county ordinances. I will report all arrests to my Probation and Parole Officer within 48 hours.
2. TRAVEL: I will obtain advance permission from my Probation and Parole Officer before leaving the state or the area in which I am living.
3. RESIDENCY: I will notify my Probation and Parole Officer of any changes in residency within 48 hours.
4. EMPLOYMENT: I will maintain employment unless engaged in a specific program approved by my Probation and Parole Officer. I will obtain advance permission from my Probation and Parole Officer before quitting my job or program. In the event I lose my job or am terminated from a program, I will notify my Probation and Parole Officer within 48 hours.
5. ASSOCIATION: I will not associate with any person who has been convicted or placed on probation for a felony or misdemeanor. It is my responsibility to know with whom I am associating.
6. DRUGS: I will not have in my possession or use any controlled substance except as prescribed for me by a licensed medical practitioner.
7. WEAPONS: I will, if my probation or parole is based on a misdemeanor involving firearms or explosives, or any felony that not own, possess, purchase, receive, sell or transport any firearms, ammunition or explosive device or any dangerous weapons defined by federal, state or municipal laws or ordinances.
8. REPORTING/DIRECTIVES: I will report as directed to my Probation and Parole Officer. I agree to abide by any directives given to me by my Probation and Parole Officer.
9. SPECIAL CONDITIONS:
  - A. You shall attend and successfully complete the Sexual Offenders Program at Fulton, Missouri.
  - B. You shall pay court costs and Crime Victims Compensation Judgment and Public Defense Judgment totaling \$461.00, to the: Barton County Circuit Clerk, Courthouse, Lamar, MO 64759. Payments shall be made under direction of the Probation Officer.
  - C. A judgment in the amount of \$68.00 is owed and due from John C. McClane for the Crime Victims Compensation Fund.

## Former minister pleads guilty

A former minister of the Lamar Church of Christ was placed on probation Monday after pleading guilty to a rape charge.

John C. McClane, 34, 1208 Grand, was sentenced to five years in the Department of Corrections, then placed on five years supervised probation by Circuit Court Judge David Darnold.

McClane admitted he had sex with a girl younger than 14 years old between April 1 and June 1 of this year.

Another condition of his probation is that he must attend and complete a sexual offender program at Fulton.

McClane left his position at the church earlier this year.
