This is in response to your inquiry regarding the above matter. Please be advised that Mr. O'Neal was indicted on August 25, 1985 for 11 counts of sexual assault upon children and 11 counts of endangering the welfare of the children. He entered pleas of guilty to 5 counts of sexual assault (second degree crimes) and was sentenced by Superior Court Judge Richard Williams in March 1986 to five years probation, and 150 hours of community service not involving children.

After his conviction he resided with his employer in Dennisville, New Jersey. He thereafter moved to [REDACTED], Williamstown, New Jersey.

in Del and Treatment Center in Avenel, Middlesex County. All people who either plead guilty to or are convicted of sex crimes are required to undergo physical and mental examinations at Avenel, which is operated by the state Department of Corrections.

The Avenel report claimed that O'Neal is not likely to commit such offenses again and that he

will respond favorably to rehabilitation during probation.

Williams also considered O'Neal's health problems and the fact that he showed remorse when he pleaded guilty.

The judge issued the sentence despite a request from the Prosecutor's Office that O'Neal spend the next five years in prison.

A prison sentence might have served to deter others from com-

mitting similar crimes, Assistant Prosecutor Susan Williams said. She also said she was not satisfied that O'Neal no longer presents a danger to the community.

Middle Township police began an investigation of O'Neal on March 15, 1985, after a victim's mother reported that her child was spending long periods of time

at his house and was bringing home gifts.

Authorities searched O'Neal's house and found, among other things, about 1,300 color photos of children, magazines in which children are depicted in sexually explicit scenes, stuffed animals and other "gifts" and letters described by one police officer as "those of a courtship between a 66-year-old man and a 10-year-old girl."

O'Neal, who was a Boy Scouts aide, an altar supervisor at St.

Church in the Villas and a member of the state-sponsored Child Placement Review Board, was arrested June 15.

An indictment handed up last August charged O'Neal with sexually assaulting 11 children, all girls, under age 16, between Jan. 1, 1986, and June 15, 1986. The offenses to which he pleaded guilty occurred in and about the home between January 1984 and June 1985.

O'Neal admitted to touching the girls "but over the years and on the bathroom."


Dear Rollie:

Sex Charges Against Scout Aide Detailed

CAPE MAY COURT HOUSE — Authorities here described the life of a 66-year-old man arrested recently as one of sexual perversion dating back 30 years and victimizing dozens, perhaps hundreds of boys and girls ages 8 to 17, mostly from the quiet community of Del Haven.

Jack C. O'Neal, of the [redacted] is a pillar of the community, a Boy Scout

leader, church activist and member of a committee overseeing troubled youths. He is also a "sick man" and a "pedophile," said law enforcement officers from the Cape May County Prosecutor's Office and the Middle Township Police Department.

O'Neal is in the Cape May County jail, charged with seven counts of criminal sexual contact. He has been unable to post bail. Police said he may be charged with as many as 10 additional counts, including possession of

child pornography. Authorities said they are investigating the possibility that O'Neal had sexual contact with two of the youths in the Baysea Boy Scout District, in which he held an administrative position.

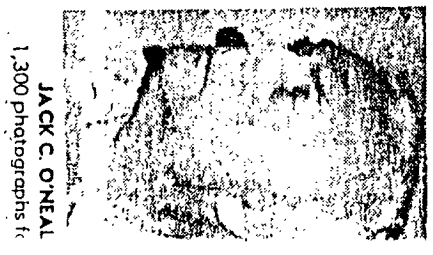
In addition to his role with the scouts, O'Neal also was involved with supervision of the altar boys at St. Raymond's Roman Catholic Church in Villas and was a member of the Cape May County Juvenile Conference Committee, charged with overseeing the

placement of area youths in foster homes, authorities said. Police said they believe O'Neal had sexual contact with at least 25 children in the time frame under investigation, but said 1,300 photographs found at his home indicate that he may have had associations with hundreds of children since 1955, when the earliest photos were taken.

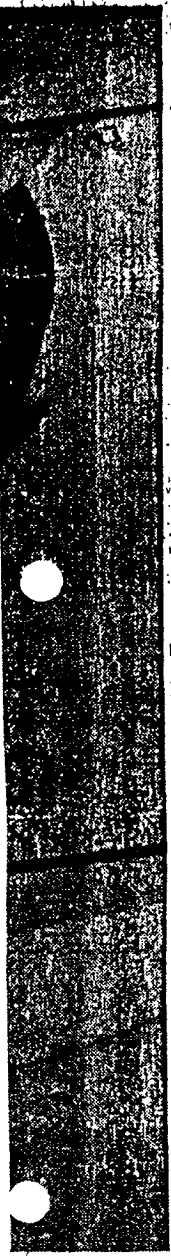
Secured in O'Neal's attic were hundreds of photographs of young boys and girls that formed the foundation of his fantasies,

the authorities said. In his bedroom were albums of photographs portraying children, many in "suggestive" poses, officials allege.

County Investigator Marie Hayes said O'Neal is a textbook case, a classic example of a pedophile, one whose sexual life is primarily based on fantasy but who must have contact with often unsuspecting children on whom to base those fantasies. O'Neal did not harm or sexually penetrate the children. Children who expressed reluctance to pose for pictures were not forced, police said.

The shock of O'Neal's alleged activities is only now beginning to affect the modest neighborhood in which he has lived for nearly 15 years, a closely knit group of families where O'Neal, a bachelor, was known for his kindness to children.

A meeting has been scheduled among parents of victims for later this week, when state social workers will answer questions and attempt to quiet concerns.

Police were alerted to O'Neal's activities as long as a year ago, but were unable to develop the necessary probable cause required to acquire a search warrant, authorities said.

The breakthrough came in March, after the mother of one victim reported that her child was spending long periods of time

In Brookton, Mass., the ordeal has nearly ended for the family of an 18-year-old college student freed Tuesday in Beirut.

Arthur Targonskis, a 1984 Brookton High School graduate studying at American University in Athens, was freed along with a Greek folk singer and an American woman.

Targonskis, who was the youngest hostage still being held among the passengers, had been on his way home for a school vacation.

At Andrews Air Force Base near Washington, the body of Robert D. Seibem, the young Navy construction diver slain aboard the hijacked jetliner, was flown home, met by his family,

Very few of the photos showed any nudity, although more than one picture showed O'Neal on his bed with a child. Police do not believe that he was assisted by an accomplice in the photography, but was either aided by children or triggered the camera remotely.

Some 500 pieces of other evidence, including pornographic magazines in which children are depicted in sexually explicit scenes, in addition, pornographic books featuring children were taken from the home.

On Saturday police moved in for the arrest. His reaction was complete surprise that he'd finally been caught up with. Teasentz said.

Sanders said O'Neal's actions had not caused trauma to the children he associated with because O'Neal told the children "that what they did was good."

"The trauma would come with a trial," he said. "And we have asked the parents, specifically, to tell their children that what they did was not wrong, not their fault, but was someone else's fault. We have also recommended that the parents be alert for mood changes and anything along those lines, to get counseling right away if needed."

Mayor Michael Voll said he regards O'Neal as less a criminal than a "sick man."

"I just hope that the man gets the help that he needs. I hope that people don't look down on him. He just needs help," Voll said.
